RESOLUTION NO. 3850 NAMING THE NEWLY APPROVED PARK AT THE CORNER OF HOPE STREET AND LARGO DRIVE "MARILYN TREFRY PARK" IN CONFORMANCE WITH SECTION 21 OF THE CODE OF ORDINANCES

WHEREAS, pursuant to Section 21-1 of the Code of Ordinances, a request to name the newly approved park at the corner of Hope Street and Large Drive "Marilyn Trefry Park" was submitted to the Board of Representatives; and

WHEREAS, Section 21-3.B of the Code of Ordinances provides that a city street, park or facility may be named to memorialize any person, inter alia, who has been deceased for more than six months prior to the request and contributed substantially to the establishment of such park or facilities or due to such person's contribution to the entire community; and

WHEREAS, the Parks and Recreation Commission approved converting this parcel into a park and leaving the selection of the name to the neighborhood at its meeting on July 20, 2016; and

WHEREAS, Marilyn Trefry passed away on December 9, 2014; and

WHEREAS, Marilyn Trefry was a founding member of the Springdale Neighborhood Association in the early 1990s who worked on numerous beautification and improvement projects and envisioned converting the corner of Hope Street and Largo Drive into a park; and

WHEREAS, the Springdale Neighborhood Association, has worked with the City of Stamford's Department of Operations to improve the lot with grass and a fence and has raised \$5000 for additional improvements to the park in order implement the vision of Marilyn Trefry.

NOW THEREFORE BE IT RESOLVED BY THE 29TH BOARD OF REPRESENTATIVES THAT:

The newly approved park at the corner of Hope Street and Large Drive be named "Marilyn Trefry Park".

This resolution shall take effect upon its adoption.
