Moorings

- Mooring status (as of 2/21/2017);

Harbor Activity

- On Sunday 2/12/2017 a minor oil sheen was reported at the north end of the West Branch. At the time, there
 were several barges at the O&G dock and a tug/oil barge was offloading at the terminal. The SFD dealt with the
 incident from shoreside but the outcome is presently unknown. (I also received an <u>anonymous</u> report from a
 member of the public that another tug had been working within the harbor and that these 'spills' occurred
 every several days.)
- I attended a meeting on 2/16/2017 at Soundwaters' Cove Island offices along with Sgt. Monck, the Deputy Harbormaster, John Davis of Care Free Boats, Mike Bagley of Soundwaters, regarding interaction between commercially operated recreational boats (including paddle boards and kayaks) and tug/barge traffic in the West Branch. We had a good discussion regarding their intentions and safety/operational matters including direct monitoring of and communication with tugs on vhf ch.13. We will continue working with both organizations to try and ensure safety for the coming season.

Garbage and Debris

- With regards to the RFQ for removal of the dangerous abandoned docks in the East Branch inside of the Hurricane gates discussed at the Commission meeting of 11/15/2016, I have requested (2/7/2017) an update from City Operations (Ernie Orgera) I am still awaiting a response. 1/14/2017, no 'official' reply yet received so I have send a follow-up e-mail requesting information. A 3rd request elicited a brief response indicating that the City was no longer willing to fund, as agreed at the meeting in late 2016, removal of the safety/environmental hazard.
- Debris build-up in the East Branch is so far minimal when compared to the last couple of years. I will continue to monitor the situation.

Harbor Commission Boat

- The Harbor Commission (Master) boat will require some pre-season maintenance;
 - o Clean hull,
 - Antifouling paint
 - \circ $\;$ Change engine fuel filters and water pump impeller.

A quotation has been obtained from city vendor Rex Marine at Norwalk (copy attached to this report) of \$1624.25 US which was accounted for in the proposed budget I submitted to the commission at the January meeting. I request the Commission's approval to have the work done.
