## RESOLUTION NO. 4075 APPROVING FEE SCHEDULE FOR TERRY CONNERS ICE RINK

**WHEREAS**, it has been determined that it is in the best interests of the City of Stamford to temporarily increase the Non-Resident Group Rate for Terry Connors Ice Rink usage fees charged by the City of Stamford (known herein as the "Temporary Non-Resident Group Rate"); and

**WHEREAS**, the Parks & Recreation Committee of the Board of Representatives held a meeting on October 20, 2020 and approved such temporary increase in fees; and

**WHEREAS**, the Board of Representatives held a meeting on November 4, 2020 and approved such temporary increase in fees.

**NOW THEREFORE BE IT RESOLVED BY THE 30<sup>TH</sup> BOARD OF REPRESENTATIVES** of the City of Stamford, pursuant to and within the limitations of Sec. C2-10-2(6) of the Charter of the City of Stamford, that it does hereby approve the following amendment and conditions thereof to the current Terry Connors Ice Rink ice rental fee schedule; and

### Ice Rental

Category	Current Rate	Proposed Rate through 6/15/21
Non-Resident Group Rate	\$485/hour	\$575/hour

**BE IT FURTHER RESOLVED** that the amendment is subject to the following conditions:


- The Temporary Non-Resident Group Rate is effective for non-contractual ice time (defined as blocks of ice time that are left over after regular customer groups have booked for the season);
- The Resident Rate will not be impacted by this rate increase;
- The Temporary Non-Resident Group Rate would apply to all Non-Resident group ice time not scheduled as of November 15. TCR will provide notice to its regular Non-Resident customers of this temporary rate increase and give them the opportunity to book ice time prior to the November 15 rate increase;
- All group ice time scheduled by Resident or Non-Resident Groups that is "given back" to the rink for re-booking, would be available to be "sold" at the Temporary Non-Resident Group Rate;
- In the event that Terry Connors Rink cannot "sell" the available ice time within one week of the available time, the rink Manager may lower the Non-Resident group rate to a rate not less than \$485/hour, provided, however, that the rink Manager shall set rates in such a manner as to maximize revenues to the rink; and

**BE IT FURTHER RESOLVED THAT** this amendment shall expire on June 15, 2021, unless further modified by the Board of Representatives.


