APPROVING A SECOND AMENDMENT OF LEASE AGREEMENT
BY AND BETWEEN THE CITY OF STAMFORD AND ZODY'S 19TH
HOLE, LLC FOR THE USE OF CITY-OWNED LAND AT E. GAYNOR
BRENNAN GOLF COURSE, STAMFORD, CONNECTICUT**

NOW THEREFORE BE IT RESOLVED BY THE 30TH BOARD OF REPRESENTATIVES THAT:

Pursuant to Section C1-50-3 of the Stamford Charter and Section 9-7 of the Stamford Code of Ordinances, the Second Amendment of Lease (the "Lease Amendment") by and between the City of Stamford (referred to as "City") and Zody's 19th Hole, LLC (referred to as "Zody's"), for the use of City-owned land at E. Gaynor Brennan Golf Course, as more particularly described in the lease and on Exhibits D and E to the Lease Amendment, for a term until June 30, 2031 with an additional five-year option, in accordance with the terms of the Lease Amendment, as more particularly described therein; and

The Mayor is hereby authorized to execute such Lease Amendment and to execute any instrument he deems necessary or desirable in connection with the execution of the Assignment and Amendment of Lease.
