3. PR30.004
REVIEW; Maintenance, Upkeep and Future Plans for Marinas
02/07/18 – Submitted by Reps. Sherwood and Figueroa
Report Made & Held

Rep. Sherwood explained that she put this item and item 4 on the agenda in response to constituent concerns regarding the condition of Cove Marina, particularly the need for it to be dredged, and the lack of electricity since Hurricane Sandy. She read the attached letters from constituents into the record.

Mr. Fedeli and Mr. Murray discussed this item with the Committee as follows:

- The process of dredging was discussed. The City has applied for a permit approximately 3 years ago. These permits usually take 3-5 years to obtain. The invited guests and the Committee discussed various ways the city might have been able to expedite the process. One way was to hire Mr. Steadman, an outside consultant (for the Harbor Commission). Another was to allow the Harbor Commission to pursue the permit directly. Ultimately, the decision was made to have the Engineering Department apply for, pursue and oversee the permit process.
- There is a Marina Revenue Fund, established in 2005 to pay for capital improvements to the marinas though bonding, although given Hurricane Sandy and the closing of Cummings Marina, there is not sufficient funds to allow for bonding.
- -A discussion ensued on whether there was sufficient money, including FEMA funds, to perform all the work necessary at the marinas.
- Other issues discussed included the additional dredging that needs to be performed, specifically in the West Branch, the potential need for additional marine police officers and the fire and life safety concerns that have resulted from the delay in the dredging project.
- -Action items include determining the basis to request an emergency dredge request, inviting the City Engineer and the State and City Harbor Masters to the next meeting to discuss the best plan to move forward and a more complete understanding of the funding available and needed to properly address the issue.

A motion to hold this item for further discussion next month was made, second and approved by unanimous voice vote.

4. PR30.005 REVIEW; Fee Structure for Marinas. Report Made 02/07/18 – Submitted by Reps. Sherwood and Figueroa

Rep. Sherwood said that she put this item on the agenda to see if there was any way to give boaters relief given the conditions of the marinas and holding their slips if they leave until the dredging is finished.

Mr. Fedeli distributed the <u>attached rate chart</u>. He is willing to hold a slip for someone until dredging is completed. He will need to review the Code to determine if it is possible, whether this is a policy change or needs Board action. He will send his results

to the Board office. The City charges less than market rate for smaller boats.

Co-Chair Mahoney adjourned the meeting at 7:21 p.m.
