The Parks & Recreation Committee met as indicated above. In attendance were Co-Chairs Mahoney and McGarry and Committee Member Reps. Aquila, Giordano, Matherne, Pratt, Stella and Wallace. Absent or excused were Reps. Saftic and Watkins. Also present were Reps. Cottrell, Michelson and Summerville; David Winston, Chair of the Parks & Recreation Commission and several members of the public.

Co-Chair Mahoney called the meeting to order at 7:02 p.m.

Co-Chair Mahoney noted that the Mayor was unable to attend. He read into the record an <a href="mailto:emailto

Rep. McGarry stated she was told that there have been no negotiations until yesterday afternoon and the Mayor hired an outside attorney to negotiate with the union

Committee members discussed:

- Keeping this item on the agenda
- Disappointment with a lack of communication from the administration
- The Police Commission's decision not to reappoint the Parks Police because the Parks Police are not under the supervision of the Police Department
- Whether the parks can be adequately policed without the Parks Police
- Whether the chairs should meet with the Mayor or whether the Committee could

meet another time this month.

- The hiring of police officers fall under the purview of the Police Commission
- Trying to get the Mayor to speak to the Committee prior to the end of the month
- The sense of the committee is that there be parks police

A motion to continue this meeting at a future date with the Mayor prior to the end of the month was made, seconded and approved by a vote of 9-0-0 (Reps. Mahoney, McGarry, Aquila, de la Cruz, Giordano, Matherne, Pratt, Stella and Wallace in favor).

The Committee had requested an action plan last month which it has not received, as well as the advertisements to fill the park police position.

Mr. Winston stated that the Parks & Rec Commission has always wanted Parks Police, but there has been no plan proposed by SPD to preserve Parks Police. If they go to the SPD, their priorities will not be the parks. The new ad was for a seasonal position, not a year round position.

This meeting is to be continued at a date to be determined.
