- 1) Application submitted by the City of Stamford's Technology Mgmt Dept, for a camera placement at Stamford's Hurricane Barrier, for use to monitor Hurricane Barrier conditions during times of inclement weather; and to monitor general Long Island Sound conditions during other times. The City of Stamford web site would host a live feed of this camera viewable by members of the public.
