

**ORDINANCE NUMBER 1182 SUPPLEMENTAL  
AUTHORIZING THE CREATION AND DESIGNATION OF  
THE POSITION OF BUREAU CHIEF, TRANSPORTATION, TRAFFIC &  
PARKING**

**WHEREAS**, the City of Stamford has recognized the need for a Bureau Chief, Transportation, Traffic & Parking to manage and direct all matters pertaining to the traffic functions of the City; and

**WHEREAS**, it has been determined that the best way to accomplish this goal is to create a position of Bureau Chief, Transportation, Traffic & Parking and to designate said position as unclassified; and

**WHEREAS**, the Board of Representatives has the power to create such a position pursuant to Section C2-10-2 of the City of Stamford Charter; and

**WHEREAS**, the Board of Representatives has the power to designate a newly created position as unclassified pursuant to Section C5-20-15(g) of the City of Stamford Charter.

**NOW, THEREFORE, BE IT ORDAINED BY THE 29<sup>th</sup> BOARD OF REPRESENTATIVES**, that Chapter 40 (Officers and Employees) of the City of Stamford Code of Ordinances shall be Appended as follows:

**ARTICLE XXXVI. – BUREAU CHIEF, TRANSPORTATION, TRAFFIC & PARKING**

**Sec. 40-164. Creation and designation.**

A position of Bureau Chief, Transportation, Traffic & Parking is hereby created and designated as an unclassified position in the Office of Operations to report to the Director of Operations.

**Sec. 40-165. Duties and Qualifications.**

Generally, advises the Mayor and the Director of Operations on all matters pertaining to the traffic functions of the City, in accordance with the provisions outlined in Sec. C5-30-4 of the Stamford Charter.

The duties and qualifications of the Bureau Chief, Transportation Traffic & Parking are set forth in greater detail in the position description entitled "Bureau Chief, Transportation, Traffic & Parking" as maintained by the Director of Personnel and Human Resources, which is hereby incorporated by reference as if fully set forth herein, including any additional terms and conditions of employment or duties negotiated or required from time to time when not inconsistent with this ordinance and reasonably necessary to carry out its purposes.

**Sec. 40-166. Appointing Authority.**

The appointment of the Bureau Chief, Transportation, Traffic & Parking shall be by the Director of Operations on behalf of the City.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect immediately upon approval.
