**SUMMARY OF PROPOSED ORDINANCE SUPPLEMENTAL  
AMENDING CHAPTER 11 OF THE CODE OF ORDINANCES, CIVIL  
SERVICE, CONCERNING THE AWARD OF RESIDENCY POINTS ON  
ENTRY LEVEL CIVIL SERVICE EXAMS FOR EMPLOYMENT IN THE  
CITY OF STAMFORD**

This proposed ordinance amends Chapter 11 of the Code of Ordinances, Civil Service, to provide for the addition of 5 bonus points to the final earned score of Stamford residents who pass entry level civil service examinations upon submission of proof that that candidate has been domiciled in Stamford for at least 12 months prior to the date of receipt of the application for the civil service examination.
