Chair Nabel said she requested this item to be on the Agenda to be more useful for the Board of Representatives to hear from the Board of Education, Human Resources department of the Board of Education and their Attorney to see how they approach negotiations and to see their time table. She discussed attending this meeting with BOE President Heftman, who suggested that a member of the Board of Representatives should attend as an observer at the negotiation meetings. President Skigen agreed and assigned himself and Representative Fedeli to attend. Mr. Skigen did attend the meeting tonight but the Teachers Union wanted to consider whether they would want him as an observer. There is a state statute that specifies that members of the Board of Finance can attend negotiating meetings as observers. In other towns as a matter of practice both Finance and Legislative Board members can participate as a form of practice. The SAU Negotiating team met and decided that they were not comfortable with President Skigen attending the meetings so he was disinvited.

The Committee agreed to ask Corporation Council if the Legislative Body has the right to under State Law to participate in any status with Teachers Negotiations.

## Mr. Clemon Williams stated:

- Test given
- Fire Commission Met
- 16 positions filled initially (1candidate failed the background check and was replaced with one of the alternates).
   19 alternates are on the list, which is valid for two years.
- Fire Commission Selections:
  - o 2 Hispanic Males
  - o 4 Black Males
  - 2 Caucasian Females
  - 7 Caucasian Males
  - 1 Male who identified himself as 2 or more races
  - 9 previous volunteer firefighters
- Most diverse class the City of Stamford has seen
  - 12.5% females
  - o 56% Caucasians
  - 6.25% 2 or more races
