- The job did go through the regular recruitment requirements and they interviewed several candidates for this position but believed Mr. Sestito was more qualified

- Both Assistant HR Director and Labor Relations Specialist have the same pay plan grade
- The new labor relations candidate is a lawyer which is not required but beneficial
- Co-chair Figueroa would like clarification on if the Board of Education uses the labor relations Specialist and if so will there be a chargeback
