RESOLUTION NO. 3617 AUTHORIZING THE CITY TO ACCEPT A GIFT OF A 2003 GMC SAVANA 2500 VAN FROM THE SMITH HOUSE FOUNDATION, INCORPORATED

WHEREAS, the Smith House Foundation, Incorporated (the "Foundation") has graciously offered to make a gift to the City of a 2003 GMC Savana 2500 Van for exclusive use by the City of Stamford Smith House Health Care Center which was donated to the Foundation; and

WHEREAS, the van is a 2003 GMC Savana 2500 Van with a Regency Conversion package which includes the installation of a Braun Corporation Century Series 2 wheelchair transport lift system (Model #NC9551B31432), video entertainment system, and modified roof height, with an odometer reading of 107,349 miles and an approximate Kelly Blue Book value of \$7,403.00; and

WHEREAS, the availability of the vehicle for use by the City of Stamford Smith House Health Care Center will be to the great benefit of the public;



WHEREAS, under Resolution No. 2459 permits the Board of Representatives must accept gifts to the City with a value of more than Five Thousand Dollars (\$5,000.00).
