# Memorandum

**Re:** Food Establishment Re-inspection Fee

---

At its regular meeting on January 3, 2007 the Board of Selectmen approved a new schedule of fees. The fee schedule was published in the January 11, 2007 edition of the New Canaan Advertiser and became effective on February 1, 2007. Included in this new schedule was a reinspection fee of \$50.00. On April 24, 2012 the re-inspection fee was changed to \$100.00.

As of the date of this memo any food establishment that fails to pass the regularly scheduled routine inspection shall be subject to the \$100.00 re-inspection fee. The \$100.00 fee will be required for each reinspection or, if required, multiple reinspections for the same food establishment. The check shall be made payable to the Town of New Canaan when the reinspection is done.

**Note:** It might be beneficial to review previous inspection reports. A failing grade is a rating score below 80. However a violation of any one (1) of the 10 four point items is also a failing grade. (Example: a score of 96 with one four point violation is a failing grade)
