SUMMARY OF PROPOSED ORDINANCE AMENDING CHAPTER 164, NOISE, SECTION 164-5, NOISE LEVELS, CONCERNING NOISE GENERATED BY REFUSE COLLECTION ACTIVITIES

This ordinance amends Chapter 164, Section 164-5 of the Code of Ordinances to exempt from regulation noise created by refuse and solid waste collection between the hours of 4:00 a.m. and 8:00 p.m.

This ordinance shall take effect upon approval by the Commissioner of Energy and Environmental Protection, as required by CGS §22a-73(c).
