## SUMMARY OF PROPOSED ORDINANCE AMENDING CHAPTER 70, ARTICLE 1, BURGLAR AND FIRE ALARMS

This ordinance 1) increases the fine for falling to register an alarm to \$120.00; 2) increases the fine for any police or fire response to an unintentional or false alarm that is not registered to \$120.00; 3) increases the fine for any police or fire response to a second unintentional or false alarm or far any subsequent unintentional or false alarm in any calendar year if such alarm is registered to \$120.00; and 4) increases the fine for any police or fire response to a five (5) or more unintentional or false alarms during any calendar year to \$250.00 for each false alarm.

The ordinance further permits the City of Stamford to withhold the issuance of a building permit to any alarm user of record who has five hundred dollars (\$500.00) or more in unpaid alarm violation fines and permits the City of Stamford to place a lien, in the manner authorized by law, on any property which has five hundred dollars (\$500.00) or more in unpaid alarm violation fines.
