SUMMARY OF PROPOSED ORDINANCE SUPPLEMENTAL AMENDING CHAPTER 72 OF THE CODE OF ORDINANCES, ALCOHOLIC BEVERAGES, §72-2 - SALE AND CONSUMPTION ON MUNICIPAL PROPERTY

This proposed ordinance amends Chapter 72, of the Code of Ordinances, Alcoholic Beverages, Section 72-2, to prohibit 1) the consumption of, or possession of any open container of, of any Alcoholic Liquor, as defined in CGS §30-1, on or within the limits of any Public Highway or municipally owned Public Area within the City of Stamford, including in parked vehicles and 2) the consumption of, or possession of any open container of, of any Alcoholic Liquor in any building or room maintained for the sale, distribution, or dispensing of Alcoholic Liquors except in accordance with CGS Chapter 30.

Notwithstanding the foregoing, 1) the consumption of, or possession of any open container of any Alcoholic Liquor is permitted during a function, festival, event or celebration conducted on or within a Public Highway or Public Area pursuant to law, ordinance, resolution or permit authorizing such consumption and/or possession, and 2) the consumption and/or possession of beer, outside of vehicles, in non-glass containers, shall be permitted in all City of Stamford Parks that contain sporting event fields and/or beaches.

The penalty for violation of this provision shall be \$100 for each offense.
