Vice-Chair Morson called the meeting to order at 7:31 p.m.

Director Gaudett discussed the following:

- February 25, 2022 Stamford's Answering Point Viper 3 had an issue
- Viper 3 serves 35 other areas in Connecticut
- All the areas were receiving each other's 911 calls from the host
- Tried to report the problem to the AT&T 911 support center but could not get through
- AT&T could not figure out the problem and escalated it to the software company
- It was determined that the cause was from the configuration changes made early in the day for the city of Fairfield emergency communication center
- 413 911 calls entered Viper 3 at that time
- Did not miss any calls for service during this time
 - o Police Dept took 37 calls
 - o Fire and EMS took 21 calls
 - Police and Fire bought in senior leadership
- The public was notified through social media
- Chose not to use robo calls to not overload the phone system

Brittany Dube discussed the following:

- Is in the National Program
- Stamford chapter begin June 2008
- 50 active members
- Half members are Health Care professionals
- On boarding process includes
 - HIPPA Training
 - Background check
- Monthly training on different Topics
 - Physiological First Aide
 - Cultural Competency
 - Shelter Basics
- 2021 Dedicated over 530 to the MRC
- 2022 the need to support Covid has dropped so the time has been spent by having training and Community outreach
- Supports Emergency Shelters
- Grant received for \$50,000 will be used for a part-time coordinator

Chief Roach added:

- CERT (Citizens Emergency Response Team) was formed because of 9/11
- Training people to be personally prepared and to help their neighbors
- Help with training to help run big shelters and with Covid running testing sites
- 50-60 CERT members
- 8 activations a month by Chief Roach as the Emergency Manager and they are paid by Workers Comp through the State of Connecticut
- Need to look into budget increase for both programs

Fire Marshall Seely explained:

- Lack of proper repairs by their vendor
