**SUMMARY OF PROPOSED ORDINANCE
AMENDING CHAPTER 231, ARTICLE X, SECTION 231-73.A
TO ADD HIGH RIDGE ROAD @ BULL'S HEAD PLAZA**

This ordinance amends Chapter 231, Article X, Section 231-73 of the Code of Ordinances to include the intersection of High Ridge Road @ Bull's Head Plaza as an intersection where blocking the intersection, or "box," shall be prohibited. This document is prepared for the benefit of the public, solely for purposes of information, summarization and explanation. This document does not represent the intent of the legislative body of the City of Stamford for any purpose.
