## RESOLUTION NO. 3784 CONFIRMING AND ESTABLISHING FEES FOR CITY OWNED GARAGES, LOTS AND METERS

**WHEREAS**, parking rates at City-owned garages, lots and meters have been approved and amended by numerous resolutions of the Board of Representatives, and

**WHEREAS**, the Transportation Committee of the Board of Representatives considered the matter of adjustments to parking rates at city-owned garages, lots and meters at its January 19, 2016 meeting; and

**WHEREAS**, the Transportation Committee held a public hearing on February 18, 2016; and

**WHEREAS**, the 29<sup>th</sup> Board of Representatives determined that it is in the best interests of the City of Stamford to reaffirm parking rates and hours at certain City of Stamford parking garages, lots and meters and make the following changes to the City of Stamford parking garage, lot and meter fees at its March 7, 2016 regular board meeting.

**NOW, THEREFORE, BE IT RESOLVED**, that the 29<sup>th</sup> Board of Representatives, pursuant to and within the limitations of Sec. C2-10-2(6) of the Charter of the City of Stamford, does hereby approve the following fees.
