ORDINANCE NO. 1223 SUPPLEMENTAL AMENDING CHAPTER 231, ARTICLE X, SECTION 231-73.A TO REMOVE HIGH RIDGE ROAD @ BULL'S HEAD PLAZA

WHEREAS, Connecticut General Statutes §14-250b(b), provides that municipalities may, by ordinance, designate street intersections where blocking the intersection, or "box," shall be prohibited; and

WHEREAS, the City of Stamford adopted such an ordinance as Section 231, Article X, Section 231-73, in 2009; and

WHEREAS, on March 7, 2016, the Board of Representatives adopted Ordinance No. 1210, amending Section 231-73 to add the intersection of High Ridge Road @ Bull's Head Plaza as an intersection where blocking the intersection, or "box," shall be prohibited; and

WHEREAS, on March 31, 2016, the State of Connecticut Department of Transportation determined that the intersection of High Ridge Road @ Bull's Head Plaza did not "meet the criteria for a 'Do Not Block the Box' location"; and

WHEREAS, the intersection of High Ridge Road @ Bull's Head Plaza should be removed from Code §231-73 as an intersection where blocking the intersection, or "box," shall be prohibited.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF STAMFORD THAT:

Article X, Section 231-73, "Prohibition on Blocking the Box," Chapter 231, "Vehicles and Traffic," of the City of Stamford Code of Ordinances is hereby amended as follows:

231-73. Prohibition on Blocking the Box

- The provisions of subsection B shall apply to the following intersections within the City of Stamford:
 - 1. Broad Street @ Summer Street
 - 2. Atlantic Street @ North State Street
 - 3. Atlantic Street @ South State Street
 - 4. Palmers Hill Road @ Westover Road
 - 5. Roxbury Road @ Westhill Road
 - 6. Canal Street @ North State Street
 - Canal Street @ South State Street
 Elm Street @ North State Street
 Elm Street @ South State Street

 - 10. Cold Spring Road @ Long Ridge Road
 - 11. Cold Spring Road @ High Ridge Road
 - 12. Washington Boulevard @ Main Street
 - 13. Washington Boulevard @ South State Street
 - 14. Washington Boulevard @ North State Street
 - 15. Tresser Boulevard @ Glenbrook Road
 - 16. Strawberry Hill Avenue @ Prospect/Hoyt Street
 - 17. West Main Street @ West Avenue
 - 18. Greenwich Avenue @ South State Street
 - 19. Cold Spring Road @ Stillwater Road
 - 20. Roxbury Road @ Stillwater Road
 - 21. Elm Street @ Shippan Avenue
 - 22. Lockwood Avenue @ Cove Road
 - 23. Seaside Avenue @ East Main Street
 - 24. High Ridge Road @ Bull's Head Plaza
- No operator of a motor vehicle, other than a tractor-trailer unit, as defined in section 14-1 of the Connecticut general statutes, shall proceed into an intersection that has been designated in subsection A, except when making a turn, unless there is sufficient space on the opposite side of the intersection to accommodate such motor vehicle without obstructing the passage of other vehicles or pedestrians, notwithstanding the indication of a traffic control signal that would permit such operator to proceed into the intersection.
- The City of Stamford shall post signs at each designated intersection indicating that blocking the intersection is prohibited and violators are subject to a fine.
- The City of Stamford shall mark, in white paint, the boundary of each designated intersection with a line not less than one-foot in width and the area within such boundary line with parallel diagonal lines not less than one-foot in width.

Any person who violates the provisions of subsection B of this section shall have E. committed an infraction.

This ordinance shall take effect upon enactment.
