## RESOLUTION NO. 3980 CONFIRMING AND ESTABLISHING HOURS OF ENFORCMENT AND FEES FOR CITY OWNED GARAGES AND PARKING LOTS (EXCLUDING COMMUTER LOTS)

WHEREAS, the Transportation Committee held a public hearing on May 2, 2019; and

WHEREAS, the 30<sup>th</sup> Board of Representatives determined that it is in the best interests of the City of Stamford to reaffirm parking rates and hours at certain City of Stamford parking garages and lots and make the following changes to the City of Stamford parking garage and lot hours of enforcement and fees (other than commuter lots) at its June 3, 2019 regular board meeting.
