- A: Yes
- Q: Can the City provide a copy of the existing parking ticket layout and specifications?

- Q: What type of ticket stock does the City currently use; IE: Poly-Thermal or non-tear Resist?
- A: Poly-Thermal
- Q: What type of handheld enforcement device does the City currently use?
- A: Panasonic SV-E1 toughpad
- Q: Who is the City's current handheld enforcement vendor and processor?
- A: Municipal Citation Solutions
- Q: How many Genetec LPR systems does the city use for parking enforcement?
- A: We have 3 vehicles with LPR.
- Q: When was the Genetec system implemented (years in service)?
- A: 2016 & 2018

- Q: Would the city consider new LPR technology as part of this RFP?
- A: No, The City recently invested in additional Genetec LPR's.
- Q: Can the City provide information on the current on street meter vendors and if the city is seeking real time enforcement transactions similar to pay by phone?
- A: The City's on street meters are a mixture of POM meters (coins only) and IPS M5's smart meters (coins and credit cards). The multispace meters in our lots, garage and some on street are IPS MS1's. ParkMobile is our pay by phone vendor, all meters have a Parkmobile zone assigned to them. Yes we are seeking real time enforcement transactions.
- Q: Will the City be enforcing off street lots and what will the off street lots contain for meters (pay by plate, pay by space or pay & display)?
- A: Yes we enforce the City's off street lots and garages. We have multispace meters in our lots and garages (IPS MS1's). ParkMobile is our pay by phone vendor; all meters have a Parkmobile zone assigned to them. We will be using pay by plate.

All other terms and conditions of **RFP No. 746** remain the same.
