Peter,

In concert with your presentation I wanted to make you aware of some information related to staff consultation on the proposed LPR enforcement . . .

On July 30 I set up a revenue enhancement meeting which included myself, Kevin, Frank Fedeli and Director McGrath to begin discussion with a list of potential fee increases and revenue enhancement ideas in the Parks, Recreation and Cashiering & Permitting functions. One of our collective first suggestions was to propose to increase the non-resident day fee for beach parks to \$50 per day up from its current \$25. As we discussed this Kevin mentioned the possible new system of enforcement at beach parks. I suggested that at our next meeting that we ask Jim Travers to attend and discuss with him the parking variables that exist and how those would or could be handled within the structure of the new system.

With Jim in attendance at our next meeting on August 6, I along with Meg Gearhart and Ken Smith reviewed those variables with Jim at our beach parks/athletic areas and the ice rink. Jim stated that for recreational sports and the ice rink that specific codes could be given out to the teams/patrons when they park in beach park lots with multiple kiosks strategically placed in the lots. We also discussed possible exclusion of the "softball parking lots" at Cummings 1&2 during game times only. Kevin was not in attendance for the second meeting. This was a preliminary discussion focused on athletic/rink permitting.
