**SUMMARY OF PROPOSED ORDINANCE  
AMENDING CHAPTER 231, ARTICLE I,  
SECTIONS 231-2 AND 231-6, REGARDING MOVING OF VEHICLES  
TO AVOID TIME LIMITS**

This Ordinance adds a new Section 231-2 to Chapter 231, Article I, Miscellaneous Provisions to prohibit motor vehicles observed within parking spaces with maximum allowed parking times where no payment is required to be observed within 50 feet of the originally observed parking space within one hour after the expiration of the maximum allowed time for the area. This Ordinance amends section 231-6.C to make a violation of this provision a Class II violation.

**RESOLUTION  
DESIGNATING PARKING METER ZONES**

1. Shippan Avenue – from the Cummings Park Soccer Field Driveway east to the easterly property line of Cummings Park along Shippan Avenue.
