The Transportation Committee met at the above time and place. In attendance were Chair DeLuca; Vice Chair Adams; and Committee Member Reps. In view of the fact that Madison Place relates to two (2) Districts, the committee felt it would be best to discuss the issue with the 5th District Representatives. A motion to hold this item was made, seconded and approved by unanimous vote. (Reps. DeLuca, Adams, Coleman, Franzetti, Kolenberg, Giordano, Di Costanzo, Kooris, and Moore in favor.)

<sup>2</sup>2. T29.002 REVIEW; parking plan for Government Center. **REPORT MADE** 

Mayor Martin stated he did away with Reserve Spaces because he would see many of the spaces empty throughout the day. On the 1st. floor there will be a reserved space for Loading Dock and two (2) spaces for standing and drop off. He requested that on the 1st floor, meters would be installed, limiting parking to 2 hours. There would be no charge, first offense, get a warning, 2nd offense person would get a ticket. The enforcement would be 9-5. Mayor Martin stated that city vehicles would be parked at the upper floor of the Bell St. Garage, thus freeing up spaces for residents. Committee voted to have the Mayor try out this change to see if it is feasible, if it is, will then remain.

Mani Poola drew a diagram of the issues and concluded by stating that when the weather improves he will be installing pavement marking arrows in each lane as well as dotted lines for left turn lane. At a later date, working with the state, mast arm mounted lane use signs adjacent to the signal heads for the WB approach will be installed.

Chair DeLuca adjourned the meeting at 8:51 p.m.
