The Transportation Committee met at the above time and place. In attendance were Chair DeLuca, Vice Chair Pratt and Committee Member Reps. Di Costanzo, Giordano, Moore and Patterson. Absent or excused were Committee Member Reps. Adams, Franzetti and Kolenberg. Also present were Reps. Fedeli and Ryan; Josh Benson, Transportation Bureau Chief and Robert Zaitooni, Traffic Engineer.

Chair DeLuca called the meeting to order at 7:00 p.m.

Mr. Benson explained that:

- The City currently charges \$3 for an entire day of parking at the Glenbrook and Springdale lots
- The lots are full every day
- Other stations on the New Canaan line and Greenwich charge \$5/day
- Parking near the downtown train station is higher (these are private)
- By charging \$3 they are attracting parkers from other towns
- An out-of-town monthly pass is \$90, so it is cheaper for an out-of-towner to park with a day pass
- This change would bring the lot up to other lots in the area
- The rate was last increased from \$2 to \$3 in 2002

Committee members discussed the need to be able to provide monthly spaces for residents given the empty spaces in the monthly area. Mr. Benson stated that they are aware of this issue and they are trying to determine how many empty spaces are generally available in order to sell additional permits. He will get the Committee the number of spaces impacted by this change.
