Dear Stamford Public Schools Staff:

The recent arrest of Stamford High School administrators, who were charged with failing to fulfill mandatory reporting obligations to Department of Children and Families (DCF), has rightfully created great concern in the community. This is a serious issue, and one we want to ensure will never be repeated. I'd like to update the community on what the administration has done and plans to do going forward.

Here are some of the steps we have taken:

- Placed Stamford High School administrators on leave
- Required district administrators to immediately be retrained on DCF Mandated Reporting
- Collected and analyzed mandated reporting data from DCF and confirmed our referrals are consistent with similar communities in Connecticut
- Reviewed and identified any gaps in the required compliance training (more than 100 new staff members, eight of our schools, all of our social workers and central office staff members are up to date with the DCF training requirements)
- Continued to work closely with DCF to examine our procedures and protocols (contacted the DCF Area Office Director to schedule a meeting for next week)
- Met with the State's Attorney to review and address his concerns
- Contacted an independent consultant to partner with me to thoroughly review the facts regarding Stamford High School administrators

Going forward, we are taking the following steps:

- Ensure all SPS staff has completed mandated reporter training by January 9, 2015
- Ensure that our procedures and protocols are consistent across the district
- Monitor our compliance with mandated reporter training and ensure fidelity with our procedures and protocols in collaboration with DCF
- Create a mandated reporter procedure wallet card that provides staff members with clear steps to follow when making a report, to ensure uniformity of practice
- Following the fact-finding review of the Stamford High School administrators, I will make a recommendation to the Board of Education consistent with the obligations under the administrators' contract

I assure you that the Stamford Public Schools takes our obligations to protect all students seriously. We will work to become a model district to ensure that every Stamford family knows that the safety and well-being of their children is our first and most important responsibility.
