Subject: Notice of Transfer

South State Street

Stamford

This will serve to notify the City of Stamford that I, James Redeker, Commissioner of Transportation, in connection with the Stamford Transportation Center, have determined that it is in the best interest of the State to incorporate a portion of South State Street, from Greenwich Avenue easterly to Elm Street, into the state highway system, as shown on the enclosed Route Change Notice.

Pursuant to Section 13a-42 of the Connecticut General Statutes, the Commissioner of Transportation "...may take into the highway system any highway, section of highway or appurtenances thereto when said commissioner finds that it is in the best interest of the state to do so, and such highway, section of highway or appurtenances thereto conform to the definitions set out in section 13a-14..."

The effective date of this transfer is noon on May 30, 2014, which is 60 days from the date of this notice as set forth in Section 13a-45 of the Connecticut General Statutes.



I am writing to inform you that the Connecticut Department of Transportation (Department) is moving forward on incorporating a portion of South State Street into the state highway system in accordance with Connecticut General Statutes, Section 13a-14. The Department will assume all ownership and control of the South State Street right of way upon completion of the transfer as determined in the enclosed Notice of Transfer.
