STEPHEN OSMAN

A Stamford native, Stephen Osman retired from a very successful career in the wholesale drug business and began a career of public service and entrepreneurship. As Chairman of the Urban Redevelopment Commission, a position he held from 1996 to 2011, Steve was one of the earliest champions of Mill River Park.

Steve led the URC to develop the Mill River Corridor Plan that became the vehicle for establishing the Park and the Tax Increment Financing authority that provides a primary vehicle for city funding for the park and other improvements within the corridor. Throughout the creation of the Mill River Corridor as a redevelopment district, Steve was emphatic about the need to include all stakeholders in developing the vision for the corridor's redevelopment. Much of the plan's success is attributed to the inclusiveness of the process.

Steve was a founding member of the Mill River Collaborative when it was created in 2002 and continues to serve Mill River Park as a board member with dedication and distinction.


