The City of Stamford and Charter Oak Communities are working with Aris Land Studio, LLC on the master plan. This 0.75-acre park site is steep, terraced, and oddly laid out. The existing play areas are seldom used, and the park is attractive to loiterers who drink there and congregate for other intimidating activities. Charter Oak Communities is beginning renovation soon on the Lawn Hill Terrace Apartments on the property next to McKeithen Park this year. The residents and the neighborhood children deserve a safe and attractive park. We are likely to identify simple things we can do in the near term to make it a neighborhood destination, while also planning for the future.
