The President called for a moment of silence in respect to the memory of the late mother of Mr. Llewellyn J. Nilan, 10th District Representative.

The President read from the Charter, sections pertaining thereto as follows: Section 618, page 71, and Section 614, page 70.

The President said his interpretation of the Charter was that the Board would be able to vote by general consent on items about which there is no discussion or opposition.

MR. RHOADES: "We will therefore proceed in this way: If Mr. Huizinga, or any members of the Fiscal Committee wish to make a general statement first, they will do so. We will then proceed with action upon the Capital Budget first, page by page, voting by general consent upon items about which there is no discussion, voting by voice vote or other methods of voting upon items in which there is a change and then voting on the total, and finally will vote on the totals on page one of each of these books (the Capital and Operating Budgets) and at the end of the meeting will act upon a resolution including the totals of both budgets."

Fiscal Committee Report:

MR. HUIZINGA, Chairmen, presented the following report of the Fiscal Committee:

FISCAL COMMITTEE REPORT ON 1958-59 BUDGET

May 1, 1958

TO: Members of the Board of Representatives

Before submitting this report I wish to take this opportunity to personally express my appreciation to the members of this committee for their cooperation in this most important task of arriving at what we believe to be a fair, equitable and practical Operating Budget and Capital Budget for the fiscal year July 1, 1958 to June 30, 1959.

This is my fifth year on the Fiscal Committee and I have never before experience such excellent cooperation coupled with a sincere conscientious effort to arrive at a right decision. When there was disagreement among the committee members, the matter was not resolved until all members were in full agreement.

Our Board has been accused of "rubber stamp" tactics, but this accusation can never be made against any member of this committee.

It is the opinion of the members of this committee that the time has come when every effort should be made to "hold the line" on taxes. Today, there are many taxpayers in our city who have had their incomes reduced. Many people in Stamford have been forced to reduce their own personal budgets in order to survive the economic recession through which we are now passing. We believe that each and every member of this Board is personally responsible to their respective constituents and all the people of Stamford for providing those needed services at a price our citizens can afford.

It is interesting to note that as of this date funds have been appropriated for plans and/or site acquisition for the building of a Senior High Schook, two Junior High Schools and a Library addition. However, most of our citizens do not realize that the cost of these projects alone may well exceed twelve million dollars in the next few years. Add to this staggering amount, the millions of dollars required to put our pensions on a sound actuarial basis, and one begins to realize the seriousness of the financial problem which is rapidly coming to a head.

Therefore, in view of these impending demands and also because we believe that the small businessman and the small homeowner are looking to us for tax relief in this period of economic decline, your committee after many long hours of serious detailed effort, is glad to be able to submit a report, which if adopted by this Board, will result in no tax increase for the citizens of Stamford for the coming fiscal year.

THE STATE OF THE PERSON

After a thorough investigation, this committee recommends the reduction of \$25,000. to a total of \$75,000. for Junior High School plans, and also recommends the deletion of \$125,000. for Senior High School plans and site improvements.

This recommendation is made because in 1956-57 we appropriated \$75,000. and in 1957-58 we appropriated an additional \$75,000. or a total of \$150,000. for the purpose of purchasing approximately 25 acres for the building of a second Junior High School. This purchase has not been made and will not be made in this coming fiscal year, therefore these funds can be used for the Junior and Senior High School plans.

CAPITAL BUDGET - HUBBARD HEIGHTS

It is recommended that no more than \$5,000. be appropriated for fencing. In the opinion of the committee this amount is more than adequate.

CAPITAL BUDGET - FERGUSON LIBRARY

In 1956-57, we appropriated \$20,000, for plans and specifications for the building of the \$400,000. library addition. In 1957-58, we appropriated an additional \$10,000. for the same purpose. It is recommended that the Equipment Account be reduced by \$6,500. to a total of \$10,000. because we believe this amount to be adequate, particularly because of the unusually large unexpended balance in this account from the previous year.

OPERATING BUDGET - FIRE DEPARTMENT

The major reductions for this department are in the Salary Account, Equipment Account and Uniform Account.

The request for additional new equipment was reduced by \$11,000. to a total of \$3,283. because in the opinion of the committee the new \$11,000. ambulance was not a necessary addition at this time.

The reduction of \$174,131,78 to a total of \$783,533, in the salary account is due to the fact that the request of \$957,664.78 is predicated on the fact that not a single new fireman will be hired for the twelve-month 2630 period ending June 30, 1959.

Although the budget specifically states that the above figure includes 43 new personnel to conform to the 42-hour work week, this figure was actually computed on the assumption that the existing personnel would work the additional hours over the 42-hour week, and would collect overtime wages on the basis of the same salary schedule in which they are now classified.

In arriving at the justifiable amount to be included in the salary appropriation, your committee computed the actual salary now being paid to existing personnel of 147 men, to be \$733,473. This amount was increased by normal salary increments of \$8,200. to a total of \$741,673. It was also agreed to increase this amount by \$41,860. to a total of \$783,533. The increase of \$41,860. represents the salaries of 10 new firemen at a starting salary of \$4,186. each.

The committee wishes to make it clear that they believe the hiring of additional firemen over the above mentioned 10 new men, in the next fiscal year would be an action which could very well be construed as discriminatory, particularly because our Police Department was required to wait several years before they were able to hire the additional new personnel they needed because of the change to a 40-hour work week on July 1, 1951.
