### Minutes of May 14, 1962 Meeting of the 7th Board of Representatives Stamford, Connecticut

A special meeting of the Board of Representatives of the City of Stamford was held on Monday, May 14, 1962, pursuant to a "Call" from the President, Faul D. Shapero, at the Dolan Jr. High School Cafeteria, Toms Road, Stamford, Conn.

After a caucus, the meeting was called to order by the President at 7:45 P.M.

ROLL CALL was taken by the Clerk. There were 38 present and 2 absent at the calling of the roll. Mr. Connors arrived shortly thereafter, changing the roll call to 39 present and 1 absent. The absent member was Mr. Mazza.

To consider and act upon the OPERATING AND CAPITAL BUDGETS for the fiscal year 1962-1963, as transmitted by the Board of Finance on April 19, 1962.

THE PRESIDENT informed the members that he was going to interpret the rules of the Board as strictly as possible in order to achieve greater efficiency. He said he was particularly referring to the rule which says that no member shall speak more than twice on any one question. He also said a short recess would be called around 10 or 10:15 P.M.

The President explained that the meeting is called in such a way that there is one motion before the body, namely, the passage of the Operating and Capital Budgets and the Board will therefore only act on those items on which it is proposed to cut the amount that has been appropriated by the Board of Finance. In other words, any motion before the Board will be to change the amount of the appropriation downward.

The President said that, for instance, if the Fiscal Committee requests that a certain item be cut and it is the pleasure of the members to cut that item further, it will be necessary to move to amend the motion of the Fiscal Committee to further reduce the item in question. He said a vote would then be taken on the motion to amend, with a final vote taken on the original motion, and that the final vote will then be on the original motion, or as it has been amended.

THE PRESIDENT called upon the Chairman of the Fiscal Committee, Robert M. Meyers.

MR. MEYERS said he wished to thank the members of his committee for the many hours they spent in meeting on the Budget. He said the committee met on Monday, April 30th from 8 P.M. until the small hours of the morning; they met on Tuesday, May 1st; on Wednesday, May 2nd; on Tuesday, May 8th; on Wednesday, May 9th; and also on Sunday, May 13th until 10:30 P.M. and again at 5 P.M. this afternoon until the present time. He said that when members of the committee asked questions on any item, they investigated the matter thoroughly and the committee has also gone out and inspected sites whether the item was small or large.

MR. MEYERS said he wished to call the members attention to the announcement he made at the May 7th meeting in reference to whether any Board member has an interest in any particular item or department, to please contact either him or members of his committee, in order that additional information might be obtained. He announced that no one has contacted him or any member of his committee within the last week.

THE PRESIDENT announced that the first Budget to be acted upon would be the Operating Budget:

MR. MEYERS spoke in favor of leaving this item alone and not reducing it. He said anyone familiar with the operation of the department knows that the money is not spent foolishly, and it was the unanimous vote of the committee that this item be left alone.

MR. BAKER, through the Chair, inquired on what basis Mr. Johnson wished to reduce this appropriation.

MR. JOHNSON replied that the Republican members of the Board felt that, in the interests of the people of Stamford, it was their feeling that these interests would be best served if Stamford is to continue to grow as a community in which one can live and carry on a business, that the continuing increase of taxes should be held in chack. He spoke at some length.

MR. BAKER said he still did not have an answer as to why this money was not needed and that ha, also, was just as much concerned with an orderly and economic running of the government.

MR. MEYERS spoke in opposition to Mr. Johnson's motion. He said there is a great need for a draftsman and a clerk typist for this office so that those in the upper echelon can devote more time to their work. He said the committee thoroughly investigated this item and it was their unanimous vote not to reduce this item. He pointed out that the Board of Finance has already cut out a reclassification.

MR. NOLAN requested Mr. Russell's opinion as to whether or not the Planning Board needs a clerk typist and a draftsman. He said he would be guided by his opinion.

MR. RUSSELL explained the need to create these additional positions. He said it had been pointed out to them by the Planning Board that they are rather undermanned comparable to other cities the size of Stamford located in the metropolitan area.

MR. SCARELLA spoke in favor of the motion.

MR. JOHNSON corrected his motion to delete the salaries of the new personnel, the Draftsman and the Clerk-Typist II, by reducing it by \$8,040.00, making a new total for Code 134.0101 of \$29,727.00.

MR. NOLAN MOVED for a roll call vote. Seconded and CARRIED.

MR. MEYERS explained that this was a contractual relationship that the city is committed to and that a recent appropriation was to take care of the unexpired term and this amount is to take care of the next fiscal year under the contract. He explained that this cannot be cut as it represents the exact amount needed.

MR. SHERMAN called attention to the Minutes of the March 5, 1962 meeting (page 3325, item #6) at which time this Board approved a \$5,000.00 appropriation for Code 162. Group Life Insurance. He said it was his impression at that time that the insurance carrier had indicated an increase of \$5,000 for a six months period, which would mean a total increase for the year of \$10,000.

MR. NOLAN said a thing like this, which is a contractual situation, that if any member who had a question about this, should have raised it before now and asked the Chairman to look into it. He said it would appear that it is based on the number of employees and thus would account for the increase, and that the time to ask questions was when the Fiscal Committee was meeting on the budget so that they could have looked into it.

MR. SCARELLA said it was his belief that the premiums would be a little higher this year, accounting for the increase.

MR. CUSHING withdrew his motion.

In reference to the above Board of Education Budget, Mr. Meyers presented the following report of the Fiscal Committee:

The Fiscal Committee has given much consideration and thought to the question of the Board of Education Budget.

The governmental structure under which we operate provides for no control by the Board of Representatives as to how the monies allocated to the Education budget are spent. If we were to vote that a particular item . should be deleted or reduced there is no assurance that our recommendations would be followed. The Board of Education could re-allocate their budget to compensate for our recommendation. In view of the size of the budget (\$8,865,000,00) approximately 45% of the total Operating Budget - we believe that if a budget were to be treated similarly to the other city departments, economies might be accomplished.

We think that the competitive position of Stamford as to attracting new teachers is very favorable under this budget. In this budget we have accepted and approved the action of the Board of Education in raising the salary schedule which includes increase of starting pay schedules for new teachers. We believe that there will be adequate inducements for the more competent teachers to teach in Stamford. The Board of Education should have no difficulty whatsoever in staffing and equiping the new schools.

We believe that the time has arrived when the Board of Education should operate the school system well within the present budget for the next several years. We realize that there are yearly increments and other similar items which may increase. However, in view of the recent expansion of operations and increase in budget, there should be a time, and we believe this is it, to hold the line.

We believe that the Board of Education has the intention to control the future budgets. With this in mind, we recommend no further deletions from the current Board of Education budget.

### THE SMITH HOUSE

<u>Code 440,6002</u> - <u>Provisions</u>: MR. MEYERS MOVED this be reduced from \$41,062.50 to \$30,000.00, thereby cutting this by \$11,062.50. Seconded by Mr. Johnson. MR. MEYERS explained that the committee felt that the operating budget passed by the Board of Finance, which they understood was supposed to take care of a six months period, should practically take care of a 12 months period. He said it was the committee's recommendation that the Smith House be staffed in accordance with the minimum state regulations that have just been promulgated, which have reduced substantially personnel requirements for hospitals of this nature, and it was the committee's considered opinion that the staff listed for the Smith House was more than was necessary. For this reason and the fact that there was a grossly disproportionate amount for the Sunset Home which houses approximately the same number of people, they made this recommendation to reduce.

VOTE taken on the above motion to reduce and CARRIED by a vote of 31 in favor, 7 opposed, with 1 abstention (Mr. Nolan).

<u>Code 571. Belltown Fire Department</u>: MR. MEYERS MOVED this be reduced from \$50,000.00 to \$49,200.00. Seconded by Mr. Murphy.

Mr. Meyers explained the reason the committee felt this should be reduced. He said they thought the Miscellaneous Expenses were excessive and this was the way they felt about all the various volunteer fire department budgets and had accordingly recommended cuts in all of them.

MR. SCARELLA spoke in opposition to the reduction. MR. MEYERS said the committee had gone into a great deal of detail and were convinced that these requests were excessive and could easily be reduced.

VOTE taken on Mr. Meyers' motion to reduce Code 571 to \$49,200.00. CARRIED.

<u>Code 572. New Hope Fire Department</u>: MR. MEYERS MOVED this be reduced from \$70,000.00 to \$68,500.00 for the same reason he had previously given. He said they had also considered a reduction in the Building Maintenance Account of \$1,000.00, reducing that from \$7,000.00 to \$6,000.00 for the reason that it was a relatively new building. Seconded by Miss Farina.

MR. SCHWARTZ spoke in opposition to the motion.

MR. MEYERS said the members of the committee were very favorably impressed with the long hours of service given by all members of the volunteer fire departments

and the self sacrificing service that they render to the city. He pointed out that the cuts that were made by the committee are extremely minor in nature that the reduction made in the Maintenance Account for the New Hope Fire Department was considered in the light of all the other volunteer fire departments. He called Mr. Schwartz' attention to the Building Maintenance account in the Belltown Fire Department which is considerably less (\$1,186.00); the one for the Long Ridge Fire Department is \$2,500.00; and the Springdale Fire Department, built around the same time is only \$2,500.00 and the Turn-of-River Fire Department's budget for Building Maintenance is only \$1,400.00. He said the committee felt that the expenditure of \$7,000.00 was rather out of line in comparison with the others, and for these reasons the committee felt it should be reduced.
