

MINUTES OF MAY 12, 1981 - SPECIAL BUDGET MEETING

THE 16th BOARD OF REPRESENTATIVES

Stamford, Connecticut

A SPECIAL MEETING of the 16th Board of Representatives of the City of Stamford, Connecticut, was held on Tuesday, May 12, 1981, (to be adjourned to the following night, Wednesday, May 13, 1981, to complete the work), pursuant to a "CALL" from the PRESIDENT, SANDRA GOLDSTEIN, in the Legislative Chambers of the Board, Second Floor, Municipal Office Building, 429 Atlantic Street, Stamford, Connecticut 06901.

The meeting was called to Order by the President at 8:23 P.M.

PLEDGE OF ALLEGIANCE TO THE FLAG was led by President Goldstein.

CLERK OF THE BOARD ANNIE M. SUMMERVILLE took the Roll:

There were 31 members present and 9 absent. The absent members were: Burtis Flounders, Stanley Darer, Barbara McInerney, Vincent DeNicola, Patrick Joyce, John Roos, John Kunsaw, John Hogan (ill), and Paul Dziezyc (ill). Mr. Joyce came in at 8:57, making 32 present and 8 absent.

The PRESIDENT declared a QUORUM.

REP. MARIE HAWE said she would be sitting and voting in Position #6 which is Mrs. McInerney's seat (who is absent this evening) and she wished the record to so note.

CHECK OF THE VOTING MACHINE:

The machine was found to be in good working order.

"CALL" OF THE MEETING":

The following is the "CALL" of the meeting which was sent to all Board members, and which PRESIDENT SANDRA GOLDSTEIN read:

"I, SANDRA GOLDSTEIN, PRESIDENT of the 16th Board of Representatives of the City of Stamford, Connecticut, and pursuant to Section 202 of the Stamford Charter, hereby call a SPECIAL MEETING of said Board of Representatives at the following time and place:

"for the following purpose:

"To consider and act upon the CAPITAL and OPERATING BUDGETS for the fiscal year 1981-1982, as transmitted by the Board of Finance on Monday, April 20, 1981, pursuant to provisions of Chapter 613 of the Stamford Charter.

THE PRESIDENT: "I would like to discuss the ground rules under which the Budget Meetings traditionally operate. First and foremost, of course, we cannot add any appropriation that has not been acted upon by the Mayor and the Board of Finance. We cannot increase or add. The only action our Board can do is to cut an appropriation request that is before us. Now, any motion to cut a request, will require a majority vote of this Board and of those present and voting; but the Resolution that will adopt this Budget, requires, according to our Charter, 21 votes, which would be a majority of the full Board. Also, we will operate, as in the past, with a running motion that will be made by the Chairman of Fiscal. If you wish to amend said Motion, you may, after the Chairman makes his recommendation. That is about it. On behalf of the Board, I would like to thank the Fiscal Committee and their two chairpeople, Mr. Esposito and Mrs. Hawe, for the incredible hard work that they put in and the really wonderful job they have done in analyzing and bringing this Budget before us tonight."

MR. BOCCUZZI: "I would just like to make a statement before we start, and it affects the Budget later on. It is my feeling that the format of this Budget decreases accountability. It is my desire to assert the prerogatives of the Board of Finance and the Board of Representatives. Therefore, I am going to Move that whenever we come to a salary in the Groupings in the book, I am going to move that Salary Account back to what it was last year."

THE PRESIDENT said that at appropriate times, she would accept such Motions as proper.

REPORT BY CO-CHAIRMAN OF THE FISCAL COMMITTEE - REP. PAUL ESPOSITO

MR. ESPOSITO: "Thank you. I would like, before we begin, to apprise the Board members of what books we are working with, and some other major issues. Everyone should have on their desks tonight, a sheet that describes the new Groupings that Mr. Boccuzzi just referred to, and the old department division codes, and it looks like this. You should keep that as a ready reference. When we get to some of those departments, it is going to be very confusing. It was confusing with us on Saturday, and I am sure it will be confusing again tonight. But hold that list aside, and it should make it a little easier to follow.

The other point is that we will be working with the smaller book. The square book, so to speak, as opposed to the rectangular book. That is the book, the square book, that has the most accurate numbers in it. The problem with that is that the numbers of the pages do not run in order. I mean it starts with 1, 2, 3, and goes up to maybe 15 but then goes back to 1 again, so I cannot read to you a page number. What I will read to you is a code number, or a group number; and it is important that everyone follow along on the basis of the code number or the group number, and not on the basis of the page number. Page #1 starts around at around the fifteenth page, and that will change again

MR. ESPOSITO (continuing):

"The Fiscal Committee has been meeting regularly since Wednesday, April 22nd, and of course the meetings culminated on Saturday with our 14½ hour deliberation session. And I would like to thank all members of Fiscal for their devotion, dedication, and hard work the last three weeks, especially the sub-committees that Mrs. Hawe and myself appointed. Frequently throughout this session tonight and tomorrow, we will be referring to the people on the sub-committees who have done some extensive work in the particular areas to which they were assigned; for example, in Education, we had Rep. Bob Fauteux and John Hogan, who have done an excellent job in looking at the Board of Education Budget and trying to make some sense out of the whole issue. In Public Works, John O'Brien, who has special expertise in that particular area. Welfare, Rep. Betty Conti and Rep. Jerry Rybnick. In Police, Burt Flounders and Jerry Livingston.

"At our meeting on Saturday, Fiscal voted to cut a total of \$1,009,573 from the Operating Budget; we voted to cut \$894,000 from the Board of Education, for a total of \$1,903,573. We also voted to cut \$352,200 from the Capital Projects Budget, which gives us a total of \$2,629,400 in cuts.

"Let me just review some of the major cuts and some of the reasons for those cuts. We cut \$459,000 from the Public Works Department, and that one particular cut was for the Spring Clean-Up. Fiscal Committee was not overwhelmingly in support of or against this particular motion. As a matter of fact, the motion to cut it only won by a 2-1 vote, which is a total of 3 votes out of the entire Fiscal Committee. We felt that this is something that the entire Board should discuss because it affects the entire Board as well as the entire City, so when we get to that particular point, all Board members should be aware of that.

"In all the major accounts, you will note that we cut the Gasoline Accounts back, and the reason we did that is because when this budget was made up, the Finance Department was projecting \$1.50 per gallon for unleaded gasoline for the City. Now the City pays a lot less than we pay for gasoline. The City right now is paying \$1.25 a gallon for unleaded gasoline, and the Fiscal Year starts on July 1st. We felt that the increase to \$1.50 was relatively large; maybe in December that seemed a more accurate number. We didn't think it was accurate right now; and we projected, and of course this was just a "guesstimate", we projected that the gasoline for the average of the entire fiscal year 1981-82 would be \$1.40 per gallon. So we cut back, in especially the big departments, all the Gasoline Accounts based on a projected \$1.40 per gallon average for unleaded. I think that all Board members should be aware of that.

"One of the other major cuts we made was in the area of Termination Pay and Workmen's Compensation. When we get to the end of "General Government", I will point out to the Board members that there are two new line items that were never in the budget before. One is for Workmen's Compensation and one is for Termination Pay. Previously, if, let's say a Police Officer retired and had accumulated 15 or 20 days of compensation time or vacation time, he had to be paid that and that money came out of the Salary Account. The problem with

MR. ESPOSITO (continuing): "that was that he had to stay on the budget line until that money ran out or until his time ran out. The department in question could not hire someone until he was off the budget line and this created a hardship, frequently requiring more over-time to compensate for the loss of the person. The Finance Department this year decided to have a separate line in the budget for termination pay, so that in the future if a Police Officer, or anyone in any department, retires, has accumulated time, rather than coming out of the Salary Account of that department, it will come out of this special Termination Account. As a result, the department should be able to save on some productivity and also on some over-time. We made cuts on the basis of that in many salary and over-time accounts; and to explain how we did that, I would like to defer to Rep. Fauteux."

MR. FAUTEUX: "What we did was we took the total of the two reserve accounts, as we call these. As Paul mentioned, there are two specific accounts; one is the Workmen's Compensation, more commonly known as Sick Pay, and the Reserve in that account is \$148,000. The Termination Pay was \$218,000. Now, the total of that, which is \$366,000 was to be spread across all of the major departments: Public Works, Police, Fire, Smith House, etc. What we did is; we are not quite sure how this is going to work out in the coming year, and this is on the advice of the Commissioner of Finance. We have to realize this is the first attempt to try to provide for this sort of a contingency, so we ended up essentially allocating^{out} about 25% of the total \$366,000; about \$96,000 was the total reduction to Over-Time and Salary and wages spread through the Public Works Department, Police, Fire Department, and some of the other large administrative departments. I think Paul will indicate to you where these reductions have occurred. "

MR. ESPOSITO said before he begins to go into the Budget, Mrs. Hawe would like to talk about the Mill Rate and the effect of the cuts on the Mill Rate.

MRS. HAWE: "I would now like to give the Board a brief run-down of the tax rate implications based on the Operating Budgets for the City and for the Board of Education, as passed by the Board of Finance. This means that if the Budget were to stand right now as it is, before any cuts are made by us, the impact would be as follows:

The weighted average increase for all Districts is 6.8%, which is an increase of 4.2 average, 4.2 Mills. This would break down as follows:

District A would be up 3.8 mills to 70.7 Mills
District B would be up 4.1 mills to 65.4 Mills
District C would be up 4.2 mills to 57.0 Mills
District CS would be up 3.8 mills to 62.2 Mills
Auto Tax Rate would be up 4.2 mills to 65.8 Mills

Each Mill is worth approximately \$1.5 Million."

"The Operating and Capital Projects Budgets, as approved by the Board of Finance, which, as we act on them tonight are, as they come to us:

THE PRESIDENT: "Mrs. Hawe, I think it is important to note, especially for those people who may be listening to us on the radio, that these are all possible projections and that none of this - no such increase has occurred at this moment."

MRS. HAWE: "In fact, the Board of Finance is the only Board that can set the Mill Rate, but this is the calculation by the Finance Department as to what the probable increase would be. This was for our own purposes, for the Board of Representatives' Fiscal Committee's purposes when we were looking at the Budget so that we could have some idea of what, in general, the increase would be; and that's what this is. It is not a final thing by any means. The Board of Finance can add more to the Contingency than is projected here, or less, but this is fairly accurate."

MRS. CONTI: "I have several Minority Reports. Now, how would you like me to go about that, after the Chairman finishes his Report, in that area?"

THE PRESIDENT: "Yes, after the Chairman gives the Majority Report. I will call on you for the Minority Report, if you have one. in that area. So please indicate by raising your hand while he is speaking, so that I would know to put you down first."

THE PRESIDENT addressed the CLERK of the Board, Annie Summerville, stating that Mrs. Conti would be the first speaker when she has a Minority Report.

MR. WIEDERLIGHT asked if those Mill increases included the Contingency Fund.

MRS. HAWE said yes, they did.

THE PRESIDENT said the meeting will now proceed with Mr. Esposito making the Motion for Fiscal and beginning.

MR. ESPOSITO: "I would like to have a running Motion to approve the Operating Budget, and we will begin with Code 101. REGISTRAR OF VOTERS. No cuts.

THE PRESIDENT called for a vote. DEFEATED with 14 Yes, 17 No votes.

MR. ESPOSITO said they made one cut, \$100 from Conferences & Training.

MRS. CONTI MOVED to cut \$100 from 102.2933 SUBSCRIPTIONS. SECONDED.

THE PRESIDENT called for a vote on cutting \$100. APPROVED, with 17 Yes, 13 No, and 1 Abstention.

MR. ESPOSITO said the final total for the Board of Finance is \$127,291.

MR. ZELINSKI MOVED to cut \$40,000 from Code 103.5120 PROFESSIONAL AUDITING SERVICES. SECONDED.

MR. LVINGSTON MOVED THE QUESTION. SECONDED. CARRIED.

THE PRESIDENT called for a vote on the Motion to cut \$40,000. (She said Mr. Joyce is now present so there are 32 members here.) The vote was 16 in the Affirmative and 16 in the Negative. The Motion has been DEFEATED with a tie vote.

MR. ESPOSITO said the final total for the Board of Finance is \$127,291.

PLANNING BOARD

Pg. #4 - Code 104.

MR. ESPOSITO: The Planning Board submitted a request for 7 new positions, including Economic Planner, Neighborhood Planners (3), a Statistical Analyst, a Planning Draftsman, and a Clerk-Typist II.

The Board of Finance CUT out the Economic Planner, the Statistical Analyst, the Planning Draftsman, and the Clerk-Typist II, which left us with three Neighborhood Planners. The Mayor funded the 3 Neighborhood Planners, phasing them in to start three months into the fiscal year.

The Fiscal Committee voted to cut one of the Neighborhood Planners, leaving them with two; so therefore we should cut the Salary Account by \$16,354, which reflects a cut of a nine-month salary. We cut Code 104.1110 Salaries by \$16,354 to reflect three-quarters of a Neighborhood Planner position, That gives us a total in the Salary Account of \$188,607.00.

The other cut we made was in NEW EQUIPMENT, where we cut \$2,378, Code 104.2650, which leaves \$1,422.

From Code 104.2940 CONFERENCES AND TRAINING, we cut \$500., leaving \$1,000.

And in TRAVEL EXPENSES, Code 104.2942, we cut \$500, leaving \$1,000.

PLANNING BOARD (continued)

MRS. CONTI MOVED to eliminate another \$16,354 from Salary Account 104.1110, leaving a balance of \$172,253. SECONDED.

MR. CORBO MOVED THE QUESTION. SECONDED. CARRIED.

The PRESIDENT called for a vote on Mrs. Conti's Motion to cut \$16,354. APPROVED with 18 Yes and 14 No votes. That line will now read \$172,253. Mrs. Conti has another Motion to make as part of her Minority Report.

MRS. CONTI MOVED to eliminate an additional \$578 in New Equipment, Code 104.2650, which would then read \$844. SECONDED.

THE PRESIDENT called for a vote. APPROVED with 24 Yes votes, 5 No votes, and 3 Abstentions.

MR. DeLUCA MOVED to delete the other Planner, which would be \$16,354 from Code 104.1110. SECONDED.

MR. LIVINGSTON MOVED THE QUESTION. SECONDED. A DIVISION was requested.

THE PRESIDENT called for a machine vote on Moving the Question. DEFEATED. 15 Yes votes, 16 No votes, and 1 Abstention. The Question has not been moved.

Speaking in favor of the cut were: Reps. Pollard, Zelinski, Guroian, and DeLuca: also Mr. Loomis.

Speaking against the cut were: Reps. Esposito, Summerville and O'Brien; also Hawe, Donahue, Wider and Maihock.

MR. BOCCUZZI MOVED THE QUESTION. SECONDED. CARRIED.

THE PRESIDENT called for a vote on the Motion to cut an additional \$16,354 from 104.1110 Salaries. DENIED: 16 Yes, 16 No.

MRS. MAIHOCK said under Code 104.2930, she MOVES for a cut of \$100.00 from STATIONERY AND SUPPLIES, making the total after the cut \$1,100.00. SECONDED.

THE PRESIDENT called for a vote. APPROVED. 18 Yes and 14 No votes.

MRS. CONTI said she would like to make a Minority Report on this item. Government and Private Industry are two distinct and separate entities, each existing for a different purpose: business to generate profit and government to provide order and services. These two separate entities, because of their divergent purposes, are often in conflict, especially if the government sector is vigilant in its protection of the rights of the people it has sworn to serve. Thus, any union between these two natural enemies can only be an unholy alliance which bodes ill for all of us. If we fund this item now and continue to do so, within five years we will no longer have a government of the people, but instead we will have a government of the corporations, by the corporations, and for the corporations. Mrs. Conti said she would vote against this appropriation and urged all of her foresighted colleagues to do the same. Mrs. Conti MOVED to CUT the whole \$65,000. SECONDED.

Mr. Anthony Conti, Mr. Wider, and Mr. Wiederlight spoke in favor of retaining the \$65,000 in the SEAC account.

MRS. GUROIAN MOVED THE QUESTION. SECONDED. By voice vote, the Question has NOT been Moved. Mrs. Guroian requested a DIVISION.

THE PRESIDENT called for a machine vote and the Motion to Move the Question was DEFEATED with 18 Yes, 14 No; (two-thirds being required).

Speaking in favor of retaining the \$65,000 in SEAC were: Mrs. Hawe, Mr. Blum, Mr. Joyce, Mr. Fauteux, Mr. Donahue, Mr. Wiederlight, Mr. Anthony Conti.

Speaking against retaining the \$65,000 and in favor of the cut were: Mr. DeLuca, Mrs. Guroian.

THE PRESIDENT called for a vote on the Motion to cut \$65,000 from SEAC. DEFEATED with 11 Yes, 20 No, 1 Abstention.

MR. ESPOSITO said Code 106, therefore, reads \$65,000.

MR. BOCCUZZI MOVED THE QUESTION. SECONDED. CARRIED.

THE PRESIDENT called for a vote on cutting \$2,500 from Code 107.5110 Professional Legal Services, leaving zero. DEFEATED by a vote of 12 Yes, 17 No, and 3 Abstentions.

MR. ESPOSITO said the final line reads \$69,735.

MR. WIEDERLIGHT asked the total amount of the cuts thus far, and MS. SUMMERVILLE said it was \$39,564.

MRS. CONTI MOVED to cut \$87.00 from Code 110.2750 Gasoline, leaving \$1,163. SECONDED.

THE PRESIDENT called for a vote. The MOTION has CARRIED with 15 Yes, 11 No, and 6 Abstentions.

MR. ESPOSITO said the total now reads \$85,309 for that Department.

MR. ZELINSKI MOVED to cut \$200. from Code 110.2940 Conferences and Training. SECONDED.

MR. LIVINGSTON spoke against the cut.

THE PRESIDENT called for a vote from 110.2940 Conferences and Training of \$200, leaving a line total of \$200. CARRIED: 14 Yes, 12 No, and 6 Abstentions.

MR. WIEDERLIGHT MOVED to cut \$2,500 from 110.5150 Professional Consultants. SECONDED.

Speaking in favor of the cut: Mr. Zelinski.

MRS. GUORIAN MOVED THE QUESTION. SECONDED. CARRIED.

THE PRESIDENT called for a vote on cutting \$2,500 from 110.5150. DENIED: 14 Yes, 15 No, 3 Abstentions.

MR. DeLUCA MOVED to cut \$1,725 from Line 110.1130 Part-Time Help, leaving a balance of \$4,000 on that line. SECONDED.

THE PRESIDENT called for a vote on the Motion to cut \$1,725 from 110.1130 Part-Time. APPROVED: 17 Yes, 12 No, and 3 Abstentions. (Mrs. Conti's vote was changed from Abstention to Yes, as requested.) This line will now read \$4,000.

MR. ESPOSITO said the final departmental total was \$83,384.

REQUEST FOR MOTION TO RECONSIDER

MR. JOYCE MOVED to RECONSIDER the cut of a Planner under 104.1110 Salaries who is working on the West Side area; which is actually a continuance of a Planner working there and he wishes this cut reinstated. He said he was on the Prevailing Side when this item was originally voted upon. SECONDED.

THE PRESIDENT called for a vote on Reconsidering this line item. APPROVED: 16 Yes, 15 No, and 1 Abstention.

MR. JOYCE MOVED to reinstate a cut on 104.1110 Salaries of \$16,354 for the Planning Board. SECONDED.

MR. LIVINGSTON and MRS. SANTY questioned how Mr. Joyce determined that this particular Planner was working on the West Side; that two Planners were cut by the Board of Finance, two new positions. One was cut by this Board.

MR. DeLUCA agreed with this premise, questioning information received after the Board had already voted. Seven planners were originally requested.

MR. ZELINSKI spoke against Reconsideration; that it is not a precedent to be set tonight in voting on budget items.

MS. SUMMERVILLE said the question is Reconsideration and MR. JOYCE has that right to make such a motion since he voted on the Prevailing Side.

MRS. PERILLO MOVED THE QUESTION. SECONDED. CARRIED.

THE PRESIDENT said the question before the Board is whether to reinstate \$16,354. to Line Item 104.1110, which would bring that line up to \$188,607. She called for a vote. DEFEATED: 15 Yes, 16 No, 1 Abstention.

MR. ESPOSITO said the Committee cut the Salary Account 114.1110. There were three new positions requested: two office workers and an office manager. The Board of Finance previously cut out the office worker; and the Fiscal Committee cut out the office manager, so that we had a cut of \$13,156 which leaves that line at \$198,434.

MS. SUMMERVILLE MOVED that the \$13,156 be reinstated. SECONDED. She said that this Commission on Aging and the staff are very busy. She cannot see cutting an office manager in this particular account due to the fact that Mrs. Wahl is the only direction that the people have there. There are 19 staff persons there. MR. LIVINGSTON MOVED THE QUESTION. SECONDED. CARRIED.

THE PRESIDENT called for a vote on the Motion to Reinstate \$13,156 to Code 114.1110 Salaries. APPROVED: 18 Yes, 13 No, and 1 Abstention. That line will now read \$211,590.


