

MINUTES OF REGULAR BOARD MEETING

MONDAY, JULY 6, 1992

22ND BOARD OF REPRESENTATIVES

STAMFORD, CONNECTICUT

A regular monthly meeting of the 22nd Board of Representatives of the City of Stamford was held on Monday, July 6, 1992, in the Legislative Chamber of the Board of Representatives, Government Center, 888 Washington Boulevard, Stamford, Connecticut.

The meeting was called to order at 8:10 p.m. by President Richard L. Lyons.

INVOCATION was given by Rep. Scott A. Morris, D-17.

"Lord, we ask for your wisdom and guidance in the difficult decisions we are about to make this evening. Amen."

PLEDGE OF ALLEGIANCE TO THE FLAG was led by President Richard L. Lyons.

ROLL CALL was taken by Acting Clerk of the Board Mary Lou Rinaldi. Clerk Annie M. Summerville was absent. There were 38 present and two absent. Absent were Garry Clemmons (excused) and Annie M. Summerville (excused).

Acting Clerk Mary Lou Rinaldi voted from Annie Summerville's seat.

The Chair declared a quorum.

PAGE: Katalin Goencz, 8th Grade Student, Dolan Middle School.

President Lyons introduced and welcomed Katalin to the meeting. He thanked her for coming and presented her with a Certificate of Appreciation.

MAYOR STANLEY J. ESPOSITO'S ANNUAL MESSAGE FOR FISCAL YEAR 1991/92 AS PER CHARTER SECTION 3-10-6.

PRESIDENT LYONS welcomed Mayor Stanley J. Esposito to the Chambers.

The Mayor was escorted to the dais by Majority Leader John J. Boccuzzi and Minority Leader James M. Rubino.

MAYOR ESPOSITO said that it was a privilege to be present this evening to share his thoughts on the State of the City of Stamford. He said that this evening's message to the members of the Board and to the residents of the City is a message of cautious optimism. He said the optimism is based on what heretofore has been accomplished as a team. The Mayor stated that some accomplishments included a budget calling for the lowest tax increase in recent history; a reduction of the City's budget deficit; a shut down of an environmentally damaging incinerator and the consolidation of the Stamford Emergency Medical Service into a better functioning and more cost effective system for the residents of Stamford.

Mayor Esposito said that while his message is one of optimism, it must be tempered by the reality of the challenges that lie ahead; challenges that if not met head on will be barriers to our success. He said that if these challenges are dealt with effectively, they will be the city's springboard to the future. The Mayor said that the challenges fall into three different categories; economic, organizational and attitudinal. The Mayor said that we have to begin with economics. He said that the taxpaying residents and businesses are in pain while the economy is stabilizing and is a long way from being robust; that we are in a fragile state of recovery that needs to be actively managed to a state of prosperity. The Mayor stated that we must be vigilant to protect the interest of the taxpayers and cannot be satisfied with deficit reductions; the mandate is for deficit elimination.

Mayor Esposito stated that the economic conditions dictate that the policy must be continued for realistic settlements with city labor unions as the economic outlook for this decade requires that we review and renegotiate those labor policies which we can no longer afford. The Mayor said that efforts are being increased to bring the University of Connecticut downtown which would have a significant impact on Stamford's economy. He also stated that to sustain and encourage economic growth, he planned to make the Office of Economic Development a reality this year. He said that he favored a structure where the city would have a Director of Economic Development reporting directly to the Mayor with an operating budget funded initially by the private sector.

MAYOR STANLEY J. ESPOSITO'S ANNUAL MESSAGE FOR FISCAL YEAR 1991/92 (continued)

MAYOR ESPOSITO: (continuing) said that the position would function as the Director of Marketing for the City of Stamford; working with existing business councils to make it easier to do business in Stamford both for the companies that want to relocate here as well as the companies that are already in Stamford.

The Mayor stated that he has had several meetings with CEO's from the corporate community and said that he was confident that the function would be in place in the very near future. The Mayor also stated that he had recently met with the Chairman of the Board of Morgan Stanley and was told that a final decision has not yet been made regarding their relocation, and he hoped that Stamford would be their choice, but also realizes that Stamford is in fierce competition. The Mayor stated that the office of Economic Development would bring structure and order to the process of economic growth.

The Mayor said that the organizational challenge faced pertains to the daily management of the city. He said that we have and must continue to run the city like a business; there is no room for bureaucracy, decreases in productivity and most important, no room for ethical lapses for violations of policies and procedures mandated to protect the interest of the taxpayers. To this end, the Mayor assured that quick and proper requests from Boards would be carried out to determine if legal procedures were violated in the past.

The Mayor said that in looking to the future, he suggested a three part plan to prepare the city's work force for the tasks ahead:

First, he proposed the initiation of an ethics workshop for every city employee. The workshop would outline and explain the city's ethics code so that there is a better understanding of why the code is in place and what constitutes a violation of the code.

Second, the Mayor said that quality management seminars for all department heads, and programs would be conducted in conjunction with several of the major corporations in the city designated to sharpen the skills and improve the performance of managers.

Third, the Mayor said that there will be an undertaking of an operational audit of all city departments and functions to insure that we are structured, organized and staffed for the tasks that lie ahead and not for those that already have been accomplished.

The Mayor stated that there were some important decisions to be made this evening by the Board members. He said that one of the most critical challenges facing the year ahead is attitude. He said that challenge cannot be voted on or legislated but must be addressed as all of us were elected to do a job. The Mayor said that this is a difficult time and we are emerging from a time of recession, an investigation and political unrest, and were not elected to be politicians but to be leaders. The Mayor stated that the differences of the past must be laid to rest; the past should not be forgotten but concentration must be on the future and we must be driven by the policies of public interest and not political vendettas. The Mayor said that the difference between management errors and criminal actions must be recognized.

MAYOR STANLEY J. ESPOSITO'S ANNUAL MESSAGE FOR FISCAL YEAR 1991/92 (continued)

The Mayor said that the challenges we are facing are bigger than any one individual but are dwarfed by collective strength. He said that the challenge is to put the politics behind for the best interest of the City of Stamford and only by facing the future together, that the destiny to be achieved will be fulfilled.

The Mayor thanked the Board for their attention.

PRESIDENT LYONS thanked the Mayor for his presence.

9. CONSIDER AND REPORT ON APPOINTMENTS PROCESS CONCERNING APPOINTMENTS TO THE COLISEUM AUTHORITY. Submitted by Ellen E. Bromley and Annie M. Summerville, Co-Chairwomen, Appointments Committee, 6/10/92.

MRS. BROMLEY stated that at the June 30th meeting of the Committee, a discussion was held on the Coliseum Authority ordinance in regards to appointments. She said the ordinance is worded differently from sections of the Charter and ordinances dealing with the question. Mrs. Bromley said that the Committee agreed to treat Coliseum Authority appointments as the other appointments are treated despite the difference in wording.

APPOINTMENTS COMMITTEE: (continued)

MRS. BROMLEY Moved the Consent Agenda. Seconded.

PRESIDENT LYONS called for a vote to approve the Consent Agenda. APPROVED by voice vote with Mrs. Perillo abstaining on item three.

FISCAL COMMITTEE - Carmen Domonkos & Mary Lou Rinaldi, Co-Chairwomen

MRS. DOMONKOS said that the Fiscal Committee met twice; on June 24, present were Carmen Domonkos, Ralph Loglisci, Maria Nakian, Gerald Rybnick, John Hogan, Nicholas Pavia, William Kosbob, John Leydon, Thomas Pia, Marggie Laurie, Audrey Maihock and Joseph Gergle. Present at the July 1 meeting were Kurt Jetta, Mary Lou Rinaldi, William Belcher, Ralph Loglisci, William Kosbob, Joan Rinaldi, Marggie Laurie, John Hogan, Nicholas Pavia, Carmen Domonkos, Joseph Gergle, John Leydon and Maria Nakian.

Mrs. Domonkos placed items 7, 8, 10, 11, 12, 13, 20 and 22 on the Consent Agenda. All Secondary Committees concurred or waived the Secondary Committee report.

1. INQUIRY INTO THE IMPACT AND EFFECT OF RE-EVALUATION ON THE TAXPAYERS AND FISCAL CONDITION OF THE CITY OF STAMFORD. Submitted by Reps. John Hogan, Jr., D-12, Audrey Maihock, R-19, David Martin, D-19 and Maria Nakian, D-20, 12/13/91. Reports made and Held in Committee 1/6, 2/3, 3/2, 4/6, 5/4 and 6/1/92.

HELD IN COMMITTEE

MRS. DOMONKOS stated that in the last two months, the Fiscal Committee did not receive a report from the finance officer in regards to the contingency fund and the status of the deficit. She said that several members of Fiscal either voted against or abstained for those reasons.

Above also referred to EDUCATION, WELFARE AND GOVERNMENT COMMITTEE.

MRS. DOMONKOS said that the Committee voted five in favor, three opposed with one abstention to approve. Moved. Seconded.

MR. DeLUCA asked if the employees of the Museum were part of the MEA union?

MRS. DOMONKOS stated that they were not part of the MEA union but covered by the contract.

MR. DeLUCA said that he was disturbed because they are covered by the contract and are not union members therefore, they pay no union dues.

FISCAL COMMITTEE: (continued)

MS. M. RINALDI said that the Museum employees are a separate bargaining unit but their increases follow the same path as the MEA employees.

MR. DeLUCA stated that we should not pay this money when the MEA appropriation has not yet been approved.

MRS. DOMONKOS said that because the contract was settled, the MEA employees received their increases although the money was not appropriated; the Committee felt the Museum employees should receive their increases because the MEA members received theirs.

MR. DeLUCA asked if it was legal to pay the money if the funds were not approved?

MS. M. RINALDI said that it was her understanding that under fair bargaining practice, there is a time limit after the contract is signed, that payments have to be made. She said the city was taken to court in a similar situation a few years ago and was forced to pay with interest; she said that the administration felt it would be better served to pay the money rather than perhaps be exposed to interest payments.

MS. M. RINALDI said that the Board of Finance approved the funding for MEA at their June meeting but the item was not on Fiscal's agenda and the Committee did not feel comfortable in taking up the item under Suspension of Rules.

MRS. MAIHOCK said she wondered how the items on Fiscal can be voted upon when we do not know what the affect will be on the contingency fund.

MRS. DOMONKOS said that it was her understanding that funding for labor contracts is set aside in the contingency fund, but on the other additional appropriations, no additional information has been received; the last report on the contingency fund showed it was overdrawn by \$800,000 plus. Mrs. Domonkos said that she could not answer how the deficit will be affected.

MRS. MAIHOCK said that she was concerned and wondered why some of the items are not being Held until there is a better understanding of the contingency fund and deficit situation.

MR. ZELINSKY Moved to waive the Secondary Committee Report. Seconded.

PRESIDENT LYONS called for a vote to waive the report. APPROVED by voice vote with no dissenting votes.

PRESIDENT LYONS proceeded to a vote to approve \$82,137 for the Stamford Museum for salary increases. APPROVED by a vote of 27 yes, five no votes with five abstentions.

MR. SHERER said that he thought the other side of the aisle were splitting hairs and this was being done for their own political agenda and he was sorry that this was being done for the citizens of Stamford.

Mr. Sherer stated that whether the bonded debt was callable or not, in any event, the money would be used to pay off other debts, and no matter what the deficit is, the actions of items 17 and 18 would be adding \$1.8 to the deficit. Mr. Sherer urged his colleagues to vote against the item for the benefit of the citizens of Stamford and not for anyone's personal agenda.

MR. MARTIN spoke about New York City nearly going bankrupt about 20 years ago because they did not face up to the operating issues and began issuing bonds to pay for the operating deficits. Mr. Martin said that we have the same thing. He said there is a lot of bonded money around and now someone wants to cover up a deficit and use the money in short term. He said that it was time to be honest and forthright as the money is long term money and should be used as long term money and because this money is being assigned, the city does not have to go in further debt. Mr. Martin said that he would vote in favor of item 18 as it was fiscally sound and honest.

MR. KOSBOB said that there were two opinions that this is what the Charter expects the Board to do and the Charter has not been followed for many years; the Charter and the rule of law should be followed now. He said the funds must be transferred as called for in the Charter.

2. REFERRAL OF ZONING BOARD'S ACTION APPROVING AS MODIFIED APPLICATION 90-027, STAMFORD RIDGEWAY ASSOCIATES, ZONING TEXT AMENDMENT - COMMUNITY SHOPPING CENTER DISTRICT - DESIGNED (CSC-D). Submitted by Joseph A. Frattaroli, Chairman, Stamford Zoning Board, 6/5/92. Action must be taken no later than August meeting.

HELD IN COMMITTEEPUBLIC WORKS & SEWER COMMITTEE - Bobby Owens, Chairman

MR. OWENS said that the Committee met on Wednesday, July 1, 1992 at 7:00 p.m. Present were Committee members Jeff Curtis, Robert DeLuca, Fred Johnson, Ron Sabia, John Zelinsky and Bob Owens; also present were Rep. Nick Pavia, Dr. William Rosenfield, Chairman of Commission on Aging; Lou David, Supervisor of Solid Waste; Jeannette Semon, Supervisor of Liquid Waste, and Walter Manfredi of WSTC.

1. UPDATE ON STATUS OF ARCHITECTURAL DRAWINGS AND TIMETABLE FOR RENOVATIONS OF BOARD OF EDUCATION FACILITY ON HILLDALE AVENUE AS A SENIOR CITIZEN CENTER. Requested by Rep. Carmen Domonkos, D-18, 6/1/92.

HELD IN COMMITTEE

MR. OWENS said that Dr. Rosenfield from the Commission on Aging, presented the Committee with much correspondence from the Commissioner of Public Works Michael Pavia and various department heads; also preliminary architectural drawings of the facility were presented but could not be used for the final plans. Mr. Owens stated that Dr. Rosenfield expressed the desires of the seniors to get the center started. Mr. Owens said that there was no one present from the Public Works Department to address the item, therefore, the Committee voted to Hold the item.

2. PROPOSED ORDINANCE CONCERNING SEPIC TANK DISPOSAL FEES. This concerns an increase in fees for waste disposal. Submitted by Rep. Robert DeLuca, R-14, 12/13/91. Held on Pending Agenda 12/18/91 & 3/11/92. Held in Committee 3/2/92.

MR. OWENS said the Committee voted to amend the proposed ordinance under Section E.; the old text reads, "Acceptance of the contents of septic tanks or cesspools or other similar devices located outside the limits of the City of Stamford shall be determined by the Commissioner of Public Works based upon his determination of the capabilities and availability of the city's facilities and manpower to receive said contents."

Mr. Owens said the amendment would read, "E. The fees for acceptance of the contents of septic tanks or cesspools or other similar devices located outside the limits of the City of Stamford shall be determined as follows: (1) Seventy-five dollars (\$75.) for the first one thousand (1,000) gallons or fraction thereof. (2) Seven dollars and fifty cents (\$7.50) for each additional one hundred (100) gallons thereof."

PUBLIC WORKS & SEWER COMMITTEE: (continued)

MR. OWENS Moved for approval. Seconded.

PRESIDENT LYONS called for a vote to approve publication as amended. APPROVED by voice vote with five no votes, Mrs. Maihock, Mr. Belcher, Mr. LaDestro, Mr. Sherer and Mrs. Bromley.

HEALTH & PROTECTION COMMITTEE - Marggie Laurie & Audrey Maihock, Co-Chairwomen

No report.

PARKS & RECREATION COMMITTEE - Robert DeLuca & Thomas Pia, Co-Chairmen

MR. DeLUCA said the Committee met on Monday, June 29, 1992, at 7:40 p.m. Present were Committee members Thomas Pia, Gerald Rybnick, Bobby Owens, Joseph Gergle, Donald Sherer, William Kosbob and Robert DeLuca; also present were Reps. Philip Stork, Ronald Sabia and John Zelinsky as well as other members of the community that play tennis at Scalzi Park.

1. REVIEW OF TENNIS FEES. Request by Rep. Robert DeLuca, R-14, 6/5/92.

Mr. DeLuca said the Committee voted seven in favor with no opposition to revise the residents tennis fees from the present \$8.00 an hr. per court to: Residents will be required to purchase a pass with a minimum of 5 hours at \$1.00 per hour. The attendant on duty will punch the pass for each hour that the person plays. A person cannot play more than one hour per night, however if there is no one waiting to play, the person will be permitted to play again.

Mr. DeLuca Moved to approve the revised fees. Seconded.

Mr. DeLuca said that even though the vote was unanimous, 7 in favor, none opposed, that over the weekend he talked to Bob Neu and did some soul searching and to go with the pass of \$1.00 per hour per person would really equate to two people playing on the courts for \$2.00 per hour; four people would be \$4.00 per hour. Mr. DeLuca said that this would be taking a backward step in view of the fact that we are talking about user fees and trying to generate monies to see a break even point.

Mr. DeLuca said that those people attending the meeting from the community were in favor of a \$50.00 season pass for residents. Mr. DeLuca Moved to amend the Committee report to institute a \$50 season pass per resident and \$6.00 per hour per court. Seconded.

MR. KOSBOB said that in Committee, a discussion was held for approximately two hours on the prior motion. He urged all members to defeat this amendment and go with the recommendations of the Committee.

MR. MARTIN stated that the season is half over.

MR. DeLUCA said that the season was one-third over.

MR. MARTIN stated that we should not be instituting season passes in the middle of the season.

PARKS & RECREATION COMMITTEE: (continued)

MR. OWENS said that he was not in favoring of changing the fees back to the \$50.00 season pass nor the \$6.00 per hour. He said that he would prefer to stay with what the Committee voted on in the beginning with the \$1.00 fee. Mr. Owens said that even with Mr. DeLuca's \$24.00 figure, that would be more than enough to cover the expense of the court if the courts were filled; there are 24 courts and at \$2.00 per court, that is a minimum of \$24.00. He did not think the cost of the lights and attendant would cost \$24.00 an hour. Mr. Owens stated that we are trying to break even and are not out to make the user pay more than what is needed to operate the facilities.

MR. SHERER said that his understanding was that the general population is not complaining about the current fees at Scalzi Park. He said that there was a vociferous delegation at the meeting who were regular users, but that particular group had a personal interest, but on the whole, there is adequate use of the courts with the fees that are currently in place and approved by the Board this term. Mr. Sherer said that perhaps the members may want to consider either defeating the amendment or the main motion because there is something in place that is current. He said that he would vote against both of the items on the Floor for the effort to maintain the current status.

MR. PIA said that he would like to amend the amendment to stay with the \$50.00 pass plus the \$8.00 an hour; this being the same as it was last year.

MR. DeLUCA withdrew his amendment as did the Seconder.

PRESIDENT LYONS said that the amendment on the Floor is for a \$50.00 season pass plus \$8.00 an hour per court.

Mr. Pia's motion was Seconded.

MR. KOSBOB said that his statement stands and urged the Board to go with the Committee's recommendation.

MR. MARTIN Moved the question. Seconded.

PRESIDENT LYONS called for a vote to Move the question. APPROVED by voice vote.

MR. LOGLISCI wanted clarification on the Mr. Pia's amendment.

MR. PIA said that the Committee at the beginning of the season voted on \$50.00 for a season pass and if you don't have a pass, the fee would be \$8.00 an hour per court.

PRESIDENT LYONS proceeded to a vote as articulated by Mr. Pia. DEFEATED by a vote of 21 no, 16 yes votes and two not voting.

PRESIDENT LYONS said that the discussion on the Floor would be on the main motion.

MR. DeLUCA said that he recommended that the motion be denied as after talking to Bob Neu, it would cost more money just to print up the special passes. Mr. DeLuca said that by denying the motion, we would be reverting back to the original fee of \$8.00 per hour per court. He said that he hoped the Board would go against the request of \$1.00 per hour for the pass and would leave the existing fees stay as they are.

PARKS & RECREATION COMMITTEE: (continued)

MR. OWENS said that the Committee met for two hours and he was surprised that he did not know how long Mr. DeLuca talked to Mr. Neu to get his vote changed or his mind changed.

MR. DeLUCA requested a Point of personal privilege; he resented the remarks made by Mr. Owens.

PRESIDENT LYONS said that Mr. DeLuca had the right of personal privilege after the representative finished speaking.

MR. OWENS said that he was addressing the Board of Representatives. He said that the Committee met for two hours discussing the tennis courts fees and he thought it was the consensus of the Committee to go with the \$1.00 fee and it was to cover the cost from 6 p.m. to 10 p.m. in the evening. Mr. Owens also stated that the cost of \$2.00, two people playing per court, would more than cover the cost of the courts and if the charges for the bocce league, the baseball leagues, etc. are more than the costs for maintaining the sports, then we also need to look into those fees more carefully.

Mr. Owens said that he was asking the Parks and Recreation Commission and Mr. Neu to get back to the Committee with statistics as to how many people play on the courts and perhaps, with the data, we can come up with better fees but at this point, we do not have the data. He said that in the last six years or so, Parks and Rec fees have been going up and down.

PRESIDENT LYONS allowed Rep. DeLuca a point of personal privilege. President Lyons stated that all questions should be directed through the Chair to fellow Board members; once an individual Board member's name is used in your replies or statements, that's a personal privilege and the individual is entitled to respond.

MR. DeLUCA said that he resented the implication that he spent time with Bob Neu and what did he receive in return to change his vote? Mr. DeLuca stated that he did change his vote because of Bob Neu; in fact, he said that it was he that made the phone call to Bob Neu after he came home that evening, and he said to himself that he had to be crazy to go along with the vote because it was ridiculous. Mr. DeLuca said that he decided to call Bob Neu and told him what the vote was and also that he made a mistake and "I definitely plan on making an amendment on the Floor of the Board to revert back to what the fees were."

Mr. DeLuca stated that he did not want to mention any names because he did not want any personal privileges, but it seemed strange that, that evening, a certain person gave the rationale to vote for the \$8.00 hour fee because he felt that the fee should be \$75.00 for a season pass and by the time the meeting was over, the person voted for a lower fee.

Mr. DeLuca said that he did not want any implications that he made a deal with somebody and asked for an apology. He said that his record stands as a Board member, a Committee member and as a Chair member of the Committee.

PARKS & RECREATION COMMITTEE: (continued)

MR. KOSBOB Moved the question. Seconded.

PRESIDENT LYONS called for a vote to Move the question. APPROVED by voice vote with no dissenting votes.

MR. DeLUCA stated the motion; \$1.00 per hour per person to use the courts and they must purchase a pass for a minimum of five hours. He said that it would be up to Bob Neu to come up with tickets for either five hours or ten.

PRESIDENT LYONS proceeded to a vote on Mr. DeLuca's motion. APPROVED by a vote of 22 yes, 16 no votes with two not voting.

MS. MITCHELL said the Committee met and held a Public Hearing on Tuesday, June 16, 1992 at 7:00 p.m. Present were Committee member Fred Johnson, Ellen Mellis, Elaine Mitchell and Nicholas Pavia; excused were Garry Clemmons, Jeffrey Curtis and Annie Summerville. Also present for the public hearing were Nora McVeigh and Andrea Kemler of the Stamford Development Fund; Gail McLean of Family & Children Services also representing Stamford Development Fund and Richard Gitlen, Director of Community Development.

1. REQUEST FROM STAMFORD DEVELOPMENT FUND, INC. FOR \$24,000 FOR PRE-DEVELOPMENT GRANT/REVOLVING LOAN FUND AND RELATED OPERATING EXPENSES. Funds to come from Community Development Block Grant Funds. A public hearing is to be held. Request from Richard E. Taber, President, Stamford Development Fund, Inc., c/o First County Bank, 300 Main Street, Stamford, CT 06901, 5/22/92.

MS. MITCHELL said that the original request from Stamford Development Fund was for \$38,500. She said that Year 17 contingency fund has \$24,000 in unallocated funds from the Community Development Block Grant; the Committee approved this amount by a vote of four in favor with none opposed. Ms. Mitchell also stated that pursuant to Ordinance No. 687 Supplemental, Sec. 6A, a public hearing was held on the item. Moved. Seconded.

PRESIDENT LYONS called for a vote to approve item 1. APPROVED by a voice vote with no dissenting votes.

MR. MORRIS said the Committee met on Thursday, June 25, 1992 at 7:00 p.m. Committee member present were Reps. Audrey Maihock, Joseph Gergle, Jeffrey Curtis and Scott Morris. Also in attendance were Rep. Robert DeLuca; Thomas Finn, Chairman of the Greater Stamford Transit District (GSTD); Carolyn Linke, Secretary of GSTD; Thomas Weihing, Esq., Attorney for the GSTD; Stan Blitz, former member of the GSTD; Susan Prosi, former staff member at the GSTD; and Ralph Antonacci, Executive Director of the Stamford Community Arts Council.

1. MATTER OF ADVERTISING ON CITY PROPERTY. Submitted by Rep. Robert DeLuca, R-14 and Scott A. Morris, D-17, 6/1/92. Held in Committee 6/1/92.

HELD IN COMMITTEE

MR. MORRIS stated that the Committee will continue working on the item. He invited all members to read the complete Committee report given to all members which is also attached to these Minutes. Mr. Morris said that with the President's permission, he would like to yield the Floor to Mr. DeLuca who had some comments.

PRESIDENT LYONS permitted Mr. DeLuca to speak.

MR. DeLUCA stated that after several months, members of the Transit District attended a meeting of the Committee. Mr. DeLuca said the Transit District has seen its day and it is time to dissolve it and put their activities under the jurisdiction of the Traffic and Parking Department.

Mr. DeLuca said that the Transit District receives \$6,000 a year from the firm that solicits ads for the bus shelters. He said that the District has signed a one-year lease with the Stamford Community Arts Council for office space for \$200 a month when there is space in the Government Center for the District to hold their meetings.

Mr. DeLuca stated that in the budget process, conferences and seminars were cut out for all departments yet the Transit District Chairman finds it necessary to attend a yearly conference; the past year, he traveled to Houston at the cost of \$900; the District hires their own attorney and CPA even though we have a Corporation Counsel and accountants here. Mr. DeLuca said that a request has been made for all income and expenses of the District for the past two years to see what income came in and where the money has been spent.

Mr. DeLuca said that the Transit District stated that the leases for the bus shelters have all been approved by the appropriate Boards, but he has never seen one come before the Board and this was contrary to the proper procedures.

Mr. DeLuca hoped that at the next meeting, the Law Department will be present and groundwork forthcoming for the best interest of the city to have better control and to dissolve the Transit District.

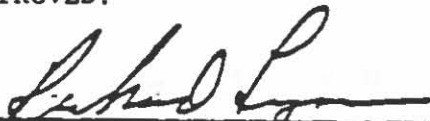
