A motion to approve Item No. 4 was made and seconded. President Skigen reported that the Committee of the Whole concurred in the recommendation of the Fiscal Committee to approve the resolution.

Rep. McMullen expressed concern about starting down the path to committing the City to spending \$55,000,000 based on the information we currently have.

Rep. Fedeli stated that she will be voting in favor and asked fellow representatives to vote in favor of this not just because of Springdale School, but because several schools are severely overcrowded and the children are suffering. As a representative who was involved in the Rogers School approval, there will be many meetings on the approval process for a new school. Postponing it for one year will have an adverse effect on the students in the schools.

Rep. Cerasoli, stated that while he believes that the school overcrowding needs to be addressed, \$55,000,000 is too large a figure to approve without certainty as to what the City cost is going to be. This amount would be competing with other capital needs of the City.

Rep. Day said he does not believe they should put a stop sign at the beginning of the road. This needs to be a collaborative effort between the Boards and the Mayor's office to explore all options available. The process can be stopped later.

Rep. Reeder stated that she concurs with Rep. Cerasoli that there are financial concerns with this. She feels that they need to do and see more analysis. They need to explore what the real options and solutions are. She is concerned about building what could be the largest school in Stamford in this district and in this congested area.

Rep. Zelinsky said that this property is in his district and a recent article in the Advocate said that many of the neighbors of the property were in support of this saying that Sacred Heart has always been a school and should be kept as such. He is concerned about traffic, but the Board of Representatives will be monitoring this and urges other representatives to support it.

Rep. Fountain stated that needs for school space are very prevalent; delaying for a year puts a risk on students. All the Board is doing is appropriating money and a resolution to apply for a grant, and will be approving many things over the next months. If the Board delays a year, it is almost a total stop sign and will delay a year and possibly two.

Rep. Savage spoke "on behalf of the students." This is 2014. She is said to hear that the same phenomena of students in broom closets is happening again today. Stamford children need a quality facility that will support their needs.

Rep. Coppola stated that he is conflicted. He can't vote against this because of the importance to the children of Stamford but he knows from experience that it will not be easy to stop a project once there is state funding. He will support this.

Rep. Silver said he will be supporting the resolution. He believes the Board will have opportunity to be sure that the City dollars are spent wisely. He recalls that there were similar concerns over the purchase of the Government Center. Have foresight for 20 to 30 years in the future.

Rep. Nabel pointed out that the City of Stamford has a track record of success in building interdistrict programs. Both AITE and Rogers have waiting lists. The Board of Representatives worked in partnership with the Board of Education and the Board of Finance on these schools.

Rep. McMullen stated that our current schools are overcrowded as a result of a failure to plan. The Board is being asked to finance this without a plan.

Rep. Di Costanzo stated that she is excited about this vote and this topic. It is important to take a stance in the City. This is not a blank check; this is an opportunity to have the best options possible moving forward. If we limit the options, we may end up paying more because we may have to make different choices, which may cost more, particularly for the students. She would like to see a unanimous vote on this.
