**WHEREAS**, Ms. Summerville was ever-present in the office, looking after the interests of all board members and office staff, attending to many details, ensuring food and snacks were available for the many night meetings; and spearheading the clearing out of a storage room to provide a comfortable meeting place for fellow representatives.
