




3 Year Fiscal Comparison by Dept.




3 Year Comparison Total Claims Fiscal




Overall Claim performance 2013/14 - 2014/15





•Fiscal 2 Year Cost Comparison




Fiscal 2 Year Cost Comparison



Overall Claim Dollar performance 2013/14 vs. 2014/15




10 yr. Claim Comparison




2014/15 total is representative of injuries without the asbestos exposures at SPD. This is the lowest amount of injuries that the city has had within a year ever.


10 yr. Dollar Comparison




BOE *Elementary* Schools YTD Incident Comparison




BOE Middle & High Schools YTD Incident Comparison



BOE Other YTD Incident Comparison




Fire Department YTD Incident Comparison






Police Department YTD Incident Comparison




