## RESOLUTION NO. 2681 REGARDING INCREASING THE MEMBERSHIP OF THE SCHOOL BUILDING COMMITTEE

WHEREAS, the School Building Committee currently consists of three members, a licensed architect, a licensed engineer and the building inspector of the City of Stamford; and

WHEREAS, it is anticipated that the role of the School Building Committee will increase due to the increasing number of capital projects; and

WHEREAS, it has been determined that it is in the best interests of the City of Stamford to increase the number of members of the School Building Committee.

NOW THEREFORE BE IT RESOLVED;

That the School Building Committee shall consist of eight (8) members.

The Mayor shall submit to the Board of Representatives, for the Board's approval, four (4) candidates for appointment to the School Building Committee. These individuals will serve terms concurrent with that of the Mayor.

The School Building Committee members submitted by the Mayor shall consist of the following:

- (1) A licensed architect who is a resident of the City of Stamford
- (2) The City Building Inspector
- (3) The City Engineer
- (4) A resident of the City of Stamford.

The remaining members of the School Building Committee shall consist of the following, each of which shall be subject to Board approval and shall serve until a replacement shall have been appointed and approved by the Board:


- (1) The President of the Board of Education or his/her designee
- (2) The Chairman of the Planning Board or his/her designee
- (3) The Chairman of the Board of Finance or his/her designee
- (4) The President of the Board of Representatives or his/her designee

This resolution is effective upon its enactment.
