Chair Diamond stated that he has since learned that since the police have the option of issuing either state citations or local ordinance citations, and since the state citations are already at \$150, there is little reason for our local fines to be less; as such, he no longer has a problem with the increase in fines.

Rep. Mirkin stated that he supports the ordinance, adding that those who park in handicapped spaces are certainly aware of it, this is a conscious decision, and the fines should be steep. He does not consider this a revenue-enhancing effort; it is solely an effort to prevent people from parking in handicapped spaces.

Rep. Lyons stated he is also not viewing this as a revenue enhancement. He added that this is something we can do to help alleviate the shortage of handicapped spaces.

Rep. Day stated he was also in support of the ordinance, and that Stamford should impose severe penalties on those who choose to park in a handicapped space.

Rep. Adams stated spoke against increasing the fine in that \$90 should be an adequate amount to prevent someone from parking in a handicapped space.

Rep. Coppola stated that the act of parking in a handicapped space is inexcusable and that he is in full support of increasing the fines to the maximum.

Rep. DeLuca stated that no one appeared at the public hearing opposed to this ordinance. In fact, he received two communications supporting the ordinance. He urged his colleagues to vote in favor of this ordinance.
