## RESOLUTION NO. 3899 AMENDING THE CAPITAL BUDGET FOR FISCAL YEAR 2017-2018 BY INCREASING THE APPROPRIATION BY \$108,453.26 FOR THE C43034 MULTI-USE BUILDING CONSTRUCTION PROJECT TO BE FUNDED BY CLOSE-OUTS

**WHEREAS**, the Board of Representatives and the Board of Finance of the City of Stamford, Connecticut (the "City") approved Resolution No. 3841 on May 2, 2017 (the "Prior Resolution"), which resolution authorizes general obligation bonds to be issued to finance a portion of the approved capital budget project appropriations (the "Capital Budget Projects");

**WHEREAS**, the Board of Representatives and the Board of Finance of the City desire to amend the Prior Resolution to increase the amount of the appropriation for C43034 Multi-Use Building Construction by \$108,453.26; and

**WHEREAS**, the City desires to fund said appropriation from the unexpended bond proceeds of the City's general obligation bonds from one or more full or partial project close-outs.

### **NOW THEREFORE BE IT RESOLVED BY THE BOARD OF REPRESENTATIVES OF THE CITY OF STAMFORD:**

The Capital Budget of the City for the fiscal year 2017-2018 is hereby amended to increase the appropriation for the following Capital Budget Project:

To meet said appropriation, unexpended bond proceeds in the amount of \$108,453.26 from the City's Capital Budget project, CP3680 Main Building Renovation, shall be used, representing a partial close out of said project.
