RE: Resolution authorizing the Mayor to Enter into an Agreement with the State of Connecticut, Department of Education for Funding Assistance Regarding Operation of the Stamford Day Care Program

Dear Board Members:

Enclosed is a proposed resolution authorizing me, as Mayor, to execute a contract so that the City can receive funding to assist Children's Learning Center of Fairfield County in the operation of the Stamford Day Care Program. For 2018-2019, the City expects to receive funding in the amount of \$1,951,438. There are no matching City funds required. The program provides affordable day care for up to 227 preschool children whose parent(s) meet income and work criteria established by the State of Connecticut.

The Child Care Program provides a full day program of day care including education, health, counseling, and nutritional programs to all participants and their families. The State-funded program currently operates from four centers in the City.
