## RESOLUTION NO. 3803

### APPOINTMENT OF MEMBERS OF THE BOARD OF REPRESENTATIVES TO ATTEND HEARINGS OF THE PLANNING BOARD IN PREPARATION OF A PROPOSED CAPITAL PROGRAM

**WHEREAS**, under Section C8-20-2 of the Charter and Code of the City of Stamford, as part of the Capital Budget process for the City of Stamford, the head of each department, board, commission, authority, agency and other entity receiving or expending City funds or state or federal funds granted to the City (hereinafter "department heads"), must submit a detailed estimate of all capital projects pending, or which should be undertaken within the six succeeding fiscal years, including a detailed budget, by project, for the next fiscal year to the Planning Board, to any duly delegated member of the Board of Representatives, to the Chairperson of the Board of Finance and to the Director of Administration; and

**WHEREAS**, such submission must be made by a date fixed by the Mayor not later than December 10; and

**WHEREAS**, by December 15 of each year, the department heads must present their proposed capital budgets to a joint public meeting of the Planning Board, the Board of Finance and any duly delegated member(s) of the Board of Representatives; and

**WHEREAS**, under Section C8-20-5 of the Charter and Code of the City of Stamford the Board of Representatives, may, by resolution, delegate to any members of the Board of Representatives the responsibility to attend all hearings before the Planning Board at which the department heads are heard in respect to such departmental estimates; and

**WHEREAS**, it is in the best interests of the City for the Board of Representatives to delegate certain Representatives to attend all hearings before the Planning Board in respect to such departmental estimates.


