SENSE OF THE BOARD RESOLUTION CONGRATULATING AND THANKING THE STAMFORD VETERANS PARK PARTNERSHIP ON THE REVITALIZATION OF THE VETERANS MEMORIAL PARK

WHEREAS, on November 11, 2019, the Stamford Veterans Park Partnership unveiled a renovated and revitalized Veterans Memorial Park; and

WHEREAS, this project grew out of the tragic death of Special Warfare Operator Chief (SEAL) Brian Bill on August 6, 2011, one of 30 American service members killed in action during a mission in Wardak Province of Afghanistan; and

WHEREAS, Patricia Parry and Patrick Sasser worked with Richard Redniss to determine how best to establish a memorial in Brian Bill's honor, and the decision was made to renovate Veteran's Memorial Park on Atlantic Street, thereby not only honoring Brian Bill, but also honoring all of Stamford's veterans; and

WHEREAS, numerous members of the Stamford community joined together to form an ad hoc committee to explore a public/private partnership with the City of Stamford to renovate the park, leading to the reformation of the Stamford Veterans Council and the creation of the Stamford Veterans Park Partnership, Inc., a non-profit organization, in 2018; and

WHEREAS, the first of three phases of the project was presented on Veterans Day, November 11, 2019; the second phase is scheduled for completion for official presentation on Memorial Day, 2020; and the third phase is the reconstruction of the Atlantic Street intersection, anticipated to be completed in 2021; and
