ORDINANCE REPEALING ARTICLE XVII OF CHAPTER 6 OF THE CODE OF ORDINANCES OF THE CITY OF STAMFORD ENTITLED "STAMFORD APPOINTMENTS COMMISSION" BE IT ORDAINED BY THE CITY OF STAMFORD: WHEREAS, Article XVII of Chapter 6 of the Code of Ordinances of the City of Stamford established the Stamford Appointments Commission; and WHEREAS, the Stamford Charter governs the appointment of members to City boards and commissions; and WHEREAS, Section C6-00-3(b) of the Stamford Charter provides that the Mayor "shall submit to the Board of Representatives nominations of members to each appointive Board or Commission to fill each vacancy where a term of office has expired or in the event of a vacancy"; and WHEREAS, the Stamford Charter sets forth the process for appointments to City boards and commissions; and WHEREAS, Article XVII of Chapter 6 is not required to effectuate the appointment process established by the Stamford Charter; and WHEREAS, pursuant to Section 1-14 of the Code of Ordinances, ordinances repealing provisions of the Code must set forth in full the sections to be repealed; and WHEREAS, pursuant to Section 1-15 of the Code of Ordinances, the repeal of an ordinance does not affect actions taken or

proceedings pending prior to such repeal; Section 1. Repeal. Article XVII of Chapter 6 of the Code of Ordinances of the City of Stamford, entitled "Stamford Appointments Commission," including Sections 6-121 through 6-124, is hereby repealed in its entirety.

Section 2. Effect of Repeal. The repeal of Article XVII of Chapter 6 shall not affect any act taken, obligation incurred, or proceeding pending prior to the effective date of this Ordinance.

Section 3. Codification. The Code of Ordinances of the City of Stamford shall be amended to reflect the repeal of Article XVII of Chapter 6 and said Article and Sections shall be omitted from future codifications of the Code

Section 4. Effective Date. This Ordinance shall take effect upon adoption. ORDINANCE AMENDING THE CODE OF ORDINANCES TO ESTABLISH INFORMATION REPORTING REQUIREMENTS OF THE OFFICE OF THE MAYOR WITH RESPECT TO THE APPLICANTS AND APPOINTEES OF THE CITY BOARDS AND COMMISSIONS NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF

STAMFORD THAT: Chapter 52 of the Stamford Code of Ordinances hereby be appended to add the following: ARTICLE III AFFIRMATIVE REPORTING Sec. 52-11 Boards and

Commissions Report. (a) All persons who desire to serve upon an appointive Board or Commission shall complete an application the form of which shall be determined by the Mayor, or his or her designee, in their reasonable discretion. The aforementioned application shall be accessible both online and at the office of the Town Clerk upon request.

(b) The application required pursuant to Sec. 52-11(a) shall require the applicant, and make such requirement known to the applicant, to disclose the following information: first and last name, email address, primary home residential address, confirmation of Stamford voter registration status, voting district of residence, affirmation the applicant shall abide by the Code of Ethics, and attestation the applicant certifies the information provided in the application is complete, true, and correct to the best of their knowledge. (c)

The application required pursuant to Sec. 52-11(a) shall solicit, though the applicant is under no obligation to provide, and such applicant shall be made known they are under no such obligation to provide, the following information: ethnicity, gender identity, political party, age, highest level of education, occupation, and languages spoken. (d) The Mayor, his or her designee, shall submit to the Clerk of the Board of Representatives, not less than once per month and in advance of its next regularly scheduled meeting, a written report containing (i) the data collected pursuant to Secs. 52-11(b) and (c), and (ii) the enumerated items set forth in Sec. 52-11(e), the form of which shall be determined by the Mayor, or his or her designee, in their reasonable discretion. Notwithstanding the foregoing, the Mayor, or his or her designee, may elect to provide additional information beyond that required under Sec. 52-11 to the extent they determine such information would be helpful to the Board of Representatives and is reasonably related to the subject matter of the report. (e)

The report required pursuant to Sec. 52-11(d) shall also include the total number of applicants during the Mayor's then-current term in office, number of applicants

interviewed over the same period of time, the number appointees currently serving, the number of vacant positions, and the number of appointees currently serving beyond the expiration of their term. (f) The report required pursuant to Sec. 52-11(d) shall present the data contained therein in an aggregate anonymous form and shall not be presented in such a way as to reasonably identify any individual applicant, nominee, or appointee. (g) The report required pursuant to Sec. 52-11(d) shall minimally present the data with respect to each of three distinct groups of persons: (i) those which have applied to be appointed to a Board or Commission, (ii) those which have been interviewed by an official of the City of Stamford in connection with their application, and (iii) those which have been nominated before the Board of Representatives. Sec. 52-12 Expiration Report. The Mayor or his/her designee shall provide notice to the President of the Board of Representatives of any vacancies or expired terms the vacancies or expirations of which have exceeded one-hundred and twenty (120) days from the date of such vacancy or expiration. Sec. 52-13 -- Violations and Penalties. Any officer, employee, or department head of the City of Stamford who willfully violates any provision of this Article or otherwise acts to impede access to information or refuses a request for information within a reasonable amount of time shall be considered to have violated the Code of Ethics. This Ordinance shall take effect on the first day of the next month at least thirty days after enactment.
